5 Related party transactions

The Company has taken advantage of the exemption within Section 33 of FRS 102 (Related party disclosures) in not disclosing transactions with other wholly owned entities in the Saga group of companies.

6 Ultimate parent undertaking

The immediate parent undertaking at 31 January 2019 is Titan Transport Limited, a company which is registered in England and Wales. The Company is wholly owned by Titan Transport Limited.

The financial statements of the Company have been consolidated in the group financial statements of ST&H Limited (an intermediate parent undertaking), and Saga plc (the ultimate parent undertaking), all of which are registered in England and Wales.

In respect of the year ending 31 January 2019, ST&H Limited is the parent company of the smallest group of which the Company is a member and for which group financial statements are prepared.
