This resulted in a published report which was launched by RSPCA Freedom Food in October 2014. Also in the year we continued to run Brighton Three Thinkers Business Club, a regular event for ethically minded organisations across the City of Brighton to engage to solve real life business challenges facing them in the fields of environmental and social sustainability and have to date had over 300 attendees.
