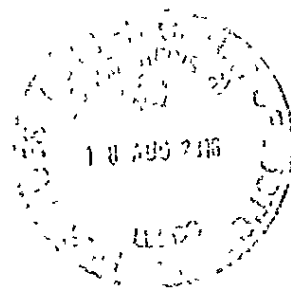

IT IS ORDERED that

1. The Bankruptcy proceedings listed in Schedule Two to this Order be transferred to the High Court of Justice, Chancery Division, Leeds District Registry solely for the purpose of the determination and disposal of this Application upon which they be transferred back to the Court from which they were transferred.
2. Pursuant to Rule 7.10C(2) of the Insolvency Rules 1986 (the Rules), the Applicant, Paul Douglas Glenn Walker be removed from office as office holder in respect of each of the insolvency cases listed in Schedules One and Two from the date of this Order.
3. Pursuant to Rule 7.10C(3) of the Rules, the First Respondent, Paul Robert Boyle be appointed as replacement office holder in respect of the insolvency cases listed in Schedule One from the date of this Order.
4. Pursuant to Rule 7.10C(3) of the Rules, the Second Respondent, David Michael Clements be appointed as replacement office holder in respect of the insolvency cases listed in Schedule Two from the date of this Order.
5. The Applicant, Paul Douglas Glenn Walker be removed and replaced by, the First Respondent, Paul Robert Boyle, as set out in Schedule One, from the date of this Order without being required to (i) convene a meeting of Creditors for each of the insolvency cases listed at Schedule One, (ii) apply to the Secretary of State for release or discharge pursuant the Insolvency Act 1986 or (iii) file a receipts and payments account.
6. The Applicant, Paul Douglas Glenn Walker be removed and replaced by, the Second Respondent, David Michael Clements, as set out at Schedule Two, from the date of this Order without being required to (i) convene a meeting of Creditors for each of the cases listed in Schedule Two, (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
7. In any matter the requirement for a progress report upon the outgoing office holder ceasing to act as set out at 2.47(3A), 6.78A(4) and 4.49C(3)(a) of the Rules shall not apply.
8. Where there are joint office holders, in respect of the insolvency cases listed at Schedules One and Two they will act jointly and severally in relation to all matters relating to the administration of the insolvency cases listed in Schedules One and Two.
9. The Creditors in each of the insolvency cases listed at Schedules One and Two be notified of the Order by advertisement published in the London Gazette within 14 days of receipt of the sealed

Order and at the time of the next statutory reporting required for each insolvency case and any appropriate notices be filed in respect of the removal of the Applicant and the appointment of the First and Second Respondents pursuant to paragraph 2, 3 and 4 of this Order with the Registrar of Companies' and the Secretary of State for Business, Innovation and Skills (Insolvency Service) as appropriate.

10. The Applicant, Paul Douglas Glenn Walker, is discharged from liability as office holder 21 days after publication of the notice in the London Gazette.
11. Any creditor who has an objection to this Order shall be at liberty to apply to the Court within 21 days of the advertisement being published in the London Gazette
12. The costs of the Application (including VAT) shall be met by the Respondents
13. Such further or other order as the Court thinks fit.
