1 Statutory information

Subco2 Ltd is a private company, limited by shares, registered in England and Wales, registration number 07118212. The registered office is 44 Harvey Road, Congleton, Cheshire, CW12 2DL.

2 Compliance with accounting standards

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

3 Accounting policies

Basis of preparation
