1. DIRECTOR'S ADVANCES, CREDITS AND GUARANTEES

At 1st April 2016 the director's loan account was a credit balance of £56,576. During the year the director withdrew £14,344 from the company. As a result at the end of the year the company owed £42,232 to the director.
