Introduction

Further to my appointment as Liquidator of the above-named company, on 4 April 2017, I write to advise that the affairs of the company are fully wound up and I therefore submit my Final Report, as required under the terms of the Insolvency Act 1986 and Insolvency Rules 2016, regarding the conduct of the liquidation.

Receipts and Payments Account

A summary of the receipts and payments account is attached herewith, confirming that the residual funds have been distributed in defraying the expenses of the liquidation, resulting in there being no prospect of any distribution to creditors in this case,

Creditors

Secured Creditors

There were no secured creditors in this liquidation.

Preferential Creditors

There were no preferential creditors in this liquidation.

Unsecured Creditors

Only one creditor claim was received in the sum of £7,986.00. As referred to above, there were insufficient funds in this case, to enable any distribution to be made to the creditors of the company.

The costs of liquidation, together with the irrecoverable VAT thereon, exceeded the balance of funds retained, which were therefore utilised to mitigate these outstanding costs.

As referred to, on the enclosed summary of costs, and as previously advised, creditors had a right to request further information in respect of the Liquidator's remuneration and expenses (in accordance with Rule 18.9 of the Insolvency (England and Wales) Rules 2016. As also referred to on the enclosed summary, and previously advised, creditors had the right to challenge the amounts drawn, under Rule 18.34. All of the above costs are subject to amendment by the firm at any time and if amended will be notified to creditors with the next circular sent to all creditors. VAT is added to disbursement charges, as necessary.
