**UPON THE APPLICATION** of Gerald Clifford Smith

**AND UPON READING** the witness statement of Gerald Clifford Smith filed in support of the  
Application

**BY CONSENT IT IS ORDERED THAT:**

1. Gerald Clifford Smith (**Outgoing Office-Holder**) be removed from office as liquidator in respect of each of the cases listed in Schedules A-C (to this order) (**Block Transfer Cases**) from the date of this order.
2. Benjamin Neil Jones (**Replacement Office-Holder**) be appointed as joint replacement liquidator in respect of each of the companies listed in Schedules A and C to this order in place of the Outgoing Office-Holder from the date of this order.

3. Arvindar Jit Singh (**Replacement Office-Holder**) be appointed as joint replacement liquidator in respect of each of the companies listed in Schedule B to this order in place of the Outgoing Office-Holder from the date of this order.
4. For the avoidance of doubt, the joint appointees of the Outgoing Office-Holder specified in respect of each of the cases listed in Schedules A to C to this order (Joint Appointees) will remain in office as liquidator and will hold office jointly together with each Replacement Office-Holder (such appointments to be joint and several). The Joint Appointees and the Replacement Office-Holders may exercise any of the powers conferred on them by the Insolvency Act 1986 either jointly or individually.
5. The creditors, or, in the case of any members' voluntary liquidation, any member, in each of the Block Transfer Cases listed in Schedules A to C be notified of this order by advertisement in the London Gazette within 28 days of the date of this order.
6. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in Schedules A to C who has an objection to this order shall have 28 days from the date of the advertisement referred to in paragraph 8 to apply to Court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases listed in Schedules A to C until further or other order by the Court.
7. The Replacement Office-Holders shall give notice to the Secretary of State and the Registrar of Companies in respect of the companies and persons (as the case may be) listed in Schedules A to C of the terms of this order as soon as reasonably practicable.
8. The Outgoing Office-Holder shall file a copy of this order with each of the Courts listed in Schedule C.
9. The Outgoing Office-Holder shall receive his release as liquidator, administrator and/or supervisor 28 days after the filing of notice of his removal with the Registrar of Companies in the case of any such appointments set out in Schedules A to C or the giving of notice to creditors in accordance with this order in any other case, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 9 of this order for the specific case subject to that application.
10. The time for service of the Application Notice and Witness Statement in support on the Respondents be abridged.
11. No order as to costs.
