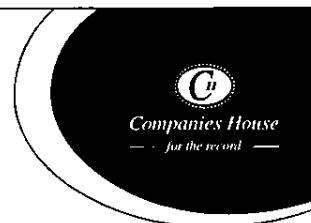

Prescribed particulars	<p>Voting On a show of hands at any general meeting every holder of Ordinary Shares who is present in person shall have one vote and on a poll every such holder who is present in person or by proxy shall have one vote for each Ordinary Share held by him</p> <p>Dividends Subject to relevant statutory provisions, the holders of the Ordinary Shares are entitled, <i>pari passu</i> amongst themselves, to the profits of the Company available for distribution and resolved to be distributed according to the amounts paid up on the Ordinary Shares held by them provided that no dividend shall be declared in excess of the amount recommended by the Directors. Interim dividends may be paid if profits are available for distribution and if the Directors so resolve. No dividends payable in respect of an Ordinary Share shall bear interest. There is no fixed date for any dividend entitlement.</p> <p>Return of capital On a winding up of the Company, the balance of the assets available for distribution shall, subject to any sanction required by statute, be divided among the members in proportion to the amount of capital paid up on each Ordinary Share.</p> <p>Redemption Subject to the relevant statutory provisions, the Ordinary Shares are not liable to be redeemed either at the option of the Company or the holders.</p> <p>Variation of rights Subject to the statutory provisions, any rights attaching to any class of share in the Company may be varied in accordance with the articles of association.</p>
