

ORDER

UPON the application of Andrew Ian McTear, Gary Rupping (aka Johannes Gerhardus Rupping) and Joanna Charlotte Watts herein dated

AND UPON READING the written evidence filed including an email from the IP Regulation Section of the Insolvency Service confirming that the Secretary of State has no objection to the proposed block transfer of cases provided for by this Order

IT IS ORDERED THAT:

- The County Court proceedings listed in Schedule C to this order be transferred to the High Court for the purpose only of this application and the making of this order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this order;
- In respect of each creditors' voluntary liquidation listed in Schedule A, attached hereto, pursuant to sections 108 and 171 of the Insolvency Act 1986 and rule 12.36 of the Insolvency Rules 2016:
 - a. Andrew John Turner be removed as liquidator;
 - b. Andrew Ian McTear and Joanna Charlotte Watts be appointed as joint liquidators.

- In respect of each members' voluntary liquidation listed in Schedule B, attached hereto, pursuant to sections 108 and 171 of the Insolvency Act 1986 and rule 12.36 of the Insolvency Rules 2016:
 - a. Andrew John Turner be removed as liquidator;
 - b. Andrew Ian McTear and Gary Rupping be appointed as joint liquidators.
- In respect of each bankruptcy listed in Schedule C, attached hereto, pursuant to section 298 of the Insolvency Act 1986 and rule 12.36(2) of the Insolvency Rules 2016:
 - a. Andrew John Turner be removed as trustees in bankruptcy;
 - b. Andrew Ian McTear and Joanna Charlotte Watts be appointed as a joint trustees in bankruptcy.
- The creditors in each of the cases listed in Schedules A and C and the members of each of the cases listed in Schedule B shall be notified of this order by way of one composite notice to be published in the Gazette within 14 days of receipt of the sealed order.
- Any creditor of the cases listed in Schedules A and C and any member of the cases listed in Schedule B who objects to this order may apply to court within 56 days of the advertisement referred to in paragraph 5 hereof, to set aside or vary the terms of this order. Any such application shall not affect the transfer of the cases listed in Schedules A to C until further order of the court.
- The replacement office-holder shall, as soon as practicable following receipt of this order, give notice to the Secretary of State of the terms of this order in relation to the cases listed in Schedules A to C of this order.
- The replacement office-holder shall give notice to the Registrar of Companies of the terms of this order in relation to cases falling within Schedules A and B and shall file a copy of this order with each of the courts listed in Schedule C.
- Without incurring any additional expense for any of the estates the Applicants shall notify each creditor of this Application and the order by way of notice at the same time as the next routine report that shall be due to the creditors of each estate, such notice to contain the following matters:
 - a. an explanation of the effect of the order;
 - b. express reference to the liberty to apply contained in paragraph 6 of this order;
 - c. where creditors' committees or liquidation committees have been appointed, an explanation that, to the extent that any information which otherwise would be required to be provided under rules 6.25 and 10.77 (as the case may be) of the Insolvency Rules 2016 has not already been provided as part of the report, it is open to that committee to require the Applicants or Andrew John Turner to provide

- an account of the administration of the estate, including a summary of receipts and payments;
- d. Where creditors' committees or liquidation committees have not been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an order that the Applicants or Andrew John Turner do provide an account of the administration of the estate, including a summary of receipts and payments.
- e. Notification that if any of the Applicants or Andrew John Turner have been required to provide the information referred to in paragraphs 14(c) or 14(d) above, whether by a liquidation committee or creditors' committee or by court order on the application of any creditor, the costs of any appointed officeholder so complying will, unless there are good reasons to the contrary, be paid as an expense of the liquidation.
- f. In each of the cases listed in Schedules A-C, notification to each creditor of their right under regulations 11(2) and 25 of the Insolvency Regulations 1994 to require the appointed officeholders to supply a statement of receipts and payments free of charge.
- In the event that, as a result of the implementation of this order McTear Williams and Wood Limited incurs any additional cost in respect of the administration of the estates listed in the Schedules to this Order where Andrew John Turner was the officeholder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates) those costs shall be borne by McTear Williams & Wood Limited and shall not be charged as an expense of the administration of those estates.
- 11 There be no order as to costs (which are to be borne by Lovewell Blake LLP).
