ORDER

UPON THE APPLICATION OF THE APPLICANT dated 20 September 2018

AND UPON the Respondent confirming his consent to the transfer of the cases identified in Schedules 1, 2 and 3 of this order

AND UPON the Court considering that the order can be made without hearing

IT IS ORDERED THAT:

1. The insolvency appointments set out in Schedules 1, 2 and 3 be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Chancery Division, for the purpose only of making the order sought in this application pursuant to Rule 12.30(7) of the Rules.
2. In relation to all the cases listed in Schedule 1 the Respondent be removed from office as officeholder and the First Applicant, Shane Biddlecombe, be appointed in his place as officeholder.
3. In relation to all the cases listed in Schedule 2 the Respondent be removed from office as joint officeholder and the Second Applicant, Gordon Johnston, be appointed in his place as joint officeholder.
4. In relation to all the cases listed in Schedule 3 the Respondent be removed from office as sole office holder and the First Applicant, Shane Biddlecombe be appointed as sole office holder in his place.
5. Immediately upon this order taking effect, the insolvency appointments listed in Schedules 1, 2 and 3 be transferred back to the court from which they were transferred (where applicable).

6. The Applicant does at the first opportunity and in any event within 3 months of the date of the Order, give notice of the Order, by advertisement in the Gazette to all creditors (and in the case of members voluntary liquidations, the members), in the cases listed in Schedules 1, 2 and 3.
7. The Applicant does at the first opportunity and in any event within 3 months of the date of the Order, give notice of the Order to the Secretary of State and the Registrar of Companies.
8. The Applicant does at the first opportunity and in any event within 3 months of the date of the Order lodge a sealed copy of the Order at any District Registry or County Court where a case listed in Schedule 1, 2 and 3 is pending.
9. The outgoing officeholder shall receive his release as liquidator, trustee or supervisor (as specified in Schedules 1, 2 and 3) 56 days after filing notification of the Order with the Secretary of State and/or Registrar of Companies as provided for in paragraph 7 save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 10 of this Order. In the event of such an application, the release will not occur for the insolvency subject of the application without further order of the Court or *decision of the Secretary of State*.
10. The creditor or, in the case of any members' voluntary liquidation, any member in any cases listed in identified in Schedules 1 and 2 should have liberty to apply to this Court within 56 days of notice of the Order made pursuant to this application having been given in accordance with paragraph 5 above.
11. Pursuant to Rule 1.3 and Schedule 3 of the Rules and Rule 3.1(2)(a) of the Civil Procedure Rules 1998 (as amended) and in respect of each of the cases listed in Schedules 1, 2 and 3 the time by which progress reports are required to be delivered by the Applicant pursuant to the Rules and/or the Insolvency Act 1986 following the Order be extended or shortened as is *applicable to the date on which such progress reports would have been required in each matter had this Order not been made*.
12. No order as to costs as between the Applicant and the Respondent save that the Applicant via HJS Recovery do pay the costs of and incidental to this Application, without HJS Recovery or any office holder having recourse to the assets in any of the estates of the cases listed in Schedules 1, 2 and 3.
