#### 2. ADMINISTRATION AND PLANNING (INCLUDING STATUTORY REPORTING)

The purpose of this report is to provide a final report to members and to put members on notice of the Liquidator's intention to resign and seek release from office. The report details the acts and dealing of the Liquidator and it should be read in conjunction with previous correspondence to members.

As Liquidator, I am required to meet a considerable number of statutory and regulatory obligations. Whilst many of these tasks do not have a direct benefit, they assist in the efficient and compliant progressing of the liquidation, which ensures that I and my staff carry out our work to high professional standards. The narrative detail in respect of these tasks may be found in Appendix 2.

#### 3. ASSET REALISATIONS

My Receipts & Payments Account for the period from 25 June 2018 to 20 February 2019 is attached at Appendix 1.

I have detailed below key information about asset realisation, however, more detailed narrative about the work undertaken may be found at Appendix 2.

According to the Declaration of Solvency lodged in these proceedings, the assets of the company had an estimated value of £2,177,351, which comprised of: Director's Loan Account 887,532, Cash at Bank £1,246,085 and Trade Debtors £43,914.

#### **Assets**

#### **Trade Debtors**

On the Declaration of Solvency, it was estimated that £43,914 was owed to the company through trade debtors. After liaising with the debtors, I realised the sum of £42,091.04.

#### **Director's Loan Account**

Having liaised with the director, the sum of £887,352.40 was distributed in specie.

#### Cash at Bank

On the Declaration of Solvency, it was estimated that a credit balance of £1,246,085 was being held in the company's bank account. Following my appointment, I formally asked the company's bankers to close the account and remit any credit balance. The sum of £1,246,084.97 was received.

#### Tax Refund

£731.71 was received into the estate account, in respect of tax refunds.

#### Bank Interest

The sum of £9.02 was received into the estate account. This has been subject to Corporation Tax of £1.81, which was paid in full on 14 February 2019.

#### 4. CREDITORS' CLAIMS & DIVIDENDS

#### **Secured Creditors**

There were no Secured Creditors in this case.

#### **Preferential Creditors**

There were no preferential creditors on the Declaration of Solvency and no preferential claims have been received.

#### **Crown Creditors**

There were no Crown Creditors in this case.

#### **Non-Preferential Unsecured Creditors**

The Declaration of Solvency included one non-preferential unsecured creditor with an estimated total liability of £4,000. I have received a claim from this creditor for a total of £4,146.

All creditors have been paid in full, payment was made to creditors on 25 June 2018. The creditor waived their right to receive statutory interest on the debt.

#### 5. HM REVENUE & CUSTOMS

I am required to obtain clearances that there are no outstanding matters, and no objections to the closure of the liquidation from both the Corporation Tax office and HMRC's Enforcement & Insolvency which provides VAT and PAYE clearances and also issues HMRC's overall claim in respect of all taxes.

Following my appointment, the Company's accountant prepared the pre-liquidation corporation tax return for the period ended 24 June 2018, which was submitted to HMRC on 26 June 2018.

The Company's accountant also prepared the pre liquidation VAT return for the period ended 24 June 2018, which was submitted to HMRC on 12 November 2018.

The Company did not operate a PAYE scheme.

I have now received all tax clearances and a final nil proof of debt from HM Revenue and Customs.

#### 6. **DISTRIBUTIONS TO SHAREHOLDERS**

The following distributions have been made to the members.

#### Distributions in cash

A first distribution of £1,230,023 was made on 26 June 2018. The rate of distribution was £65,501.15 per £1 share.

A second and final distribution of £48,992.93 was made on 13 February 2019. The rate of distribution was £2,449.65 per £1 share.

#### Distribution in specie

The Director's Loan of £887,352.40 was distributed in specie on 26 June 2018. The rate of distribution was £44,367.62 per share.

#### 7. PENSION SCHEME

As part of my duties on appointment, I carried out a search with the Pension Protection Fund ("PPF"), in addition to my initial enquiries to determine whether the Company was party to a pension scheme.

The results showed that the company operated a NEST pension scheme. NEST have been advised that the company has creased trading, and they confirmed that there are no outstanding payments to be made.

#### 8. COSTS AND EXPENSES

The payments shown on the summary of the Receipts and Payments at Appendix I are in the main self-explanatory.

#### Fixed fee agreed with the Directors and ratified by members.

The members authorised a fixed fee of £4,500 for assisting the directors in calling the relevant meetings, preparing the Declaration of Solvency and attending to matters arising in the winding up. The fee has been paid from first realisations on appointment and is shown in the enclosed receipts and payments account.

#### Liquidators' Disbursements

The Liquidators category 1 disbursements for the period 25 June 2018 to 19 February 2019 total £1,243 and represent the simple reimbursement of actual out of pocket payments made on behalf of the assignment. This is made up as follows:
