1. INTRODUCTION

- 1 1 I refer to my appointment as Joint Administrator of New Glow Urban Spa (Holdings) Limited, New Glow Urban Spa Limited and Panakeia Limited (the Companies) on 1 June 2011 by the High Court, London This was following an Administration application being made by the director in respect of NGUSH and the shareholder/companies in respect of NGUS and Panakeia, pursuant to Paragraph 12 of Schedule B1 of the Insolvency Act 1986 (the Act)
- 1 2 I write to provide you with my progress report for the six months ended 30 November 2011
 This report should be read in conjunction with my reports dated 7 June 2011 and 22 July
 2011

2. BACKGROUND

- 2 2 A full background of the Companies was provided in my previous reports, accordingly I do not propose to provide any further details on the background of the Companies or the events leading up to my appointment

3. ASSET REALISATIONS

3.1 Attached at *Appendix II* is the receipts and payments account for the Companies for the period 1 June 2011 to 30 November 2011

3 2 Cash at Bank

- 3 3 I would advise that I have received £14,251 54 from NGUSH pre appointment bankers No further realisations are expected
- A refund of £2,369 45 has been made to American Express Payment Services Limited as certain payments had incorrectly credited NGUSH pre appointment bank account and subsequently been transferred to my administration account within the cash at bank figure

3 5 Rates refund

3.6 I have received a rates refund for NGUSH of £17.42 from the City of Westminster Council No further realisations are anticipated

4. INVESTIGATIONS

- Reports' on the Directors' conduct was submitted to the Insolvency Practitioners Compliance Unit on 3 October 2011 These reports are not on public record
- Upon review of NGUSH records it was apparent that certain funds were paid to an associated entity. I am currently in correspondence with the directors of the Company regarding these payments.

- 5 1 1 There are no secured creditors
- 5 2 Dividend to preferential creditors
- 5 2 1 I have not received any preferential claims in respect of any of the Companies due to the transfer of employees to the purchaser of the business and assets, under TUPE regulations following the sale

5 3 The Prescribed Part

5 3 1 The Companies have not granted floating charges to any creditor after the 15 September 2003 and consequently there will be no prescribed part in these Administrations

5.4 Dividend to unsecured creditors

5 4 1 I would advise that after associated costs of the administrations I do not anticipate there being sufficient funds to make a distribution to the unsecured creditors of the Companies

6. JOINT ADMINISTRATORS' REMUNERATION

- Pursuant to Rule 2 106 of the Insolvency Rules 1986 (the Rules), it was agreed that the basis upon which my remuneration should be fixed post appointment would be by reference to the time properly spent by me and my staff in attending to matters arising in the Administrations It was also agreed pursuant to Rule 2 67A that the pre appointment costs of ReSolve Partners may be paid as an expense of the Administrations as and when funds permit
- My firm's pre appointment costs totalled £34,277 50 As previously advised I confirm that I have been paid the sum of £10,000 in relation to these costs by NGUSH and a third party. The balance of my fees will be written off
- The pre appointment and post appointment time costs of ReSolve Partners are as analysed at *Appendix III*
- In accordance with my previous report, my firm's time costs in respect of NGUSH, NGUS and Panakeia for the period 1 June 2011 to 22 July 2011 totalled £11,114, £1,095 50 and £513 respectively
- As detailed in my previous report, my firm's post appointment disbursements in respect of NGUSH, NGUS and Panakeia totalled £1,313 54, £360 and £360 respectively. Please note that my disbursements detailed in my previous report were incorrect and have been amended accordingly.
- 6 6 My firm's time costs for the period 23 July 2011 to 30 November 2011 in respect of NGUSH, NGUS and Panakeia total £9,757 50, £1,012 50 and £495 respectively To date I have not drawn any fees in respect of my outstanding time costs
- 6 7 I would advise that my firm's disbursements in respect of NGUSH, NGUS and Panakeia total £1,845 02, £309 96 and £309 96 respectively

- 6 8 1 An unsecured creditor may, with the permission of the court or with the concurrence of 5 per cent in value of the unsecured creditors (including the creditor in question) request further details of the Administrators' remuneration and disbursements, within 21 days of receipt of this report. Any secured creditor may request the same details in the same time limit.
- An unsecured creditor may, with the permission of the court or with the concurrence of 10 per cent in value of the unsecured creditors (including the creditor in question), apply to court to challenge the amount and/or basis of the Administrators' fees and the amount of any proposed expenses or expenses already incurred, within eight weeks of receipt of this report Any secured creditor may make a similar application to court within the same time limit

69 Solicitors' fees

As previously advised, solicitors have been instructed on a time costs basis to provide legal advice on all aspects of the Administrations. My solicitors' outstanding time costs to date amount to £17,251 50 and fees of £9,625 have been met from NGUSH Administration funds, my solicitors' outstanding fees have been written off. The solicitors' are being regularly reviewed as part of the strategic review of the case.

6 10 Agents' fees

6 10 1 As previously advised agents have been instructed on a time costs basis to realise the assets of the Companies and provide marketing advice in the Administrations. My agents' outstanding time costs to date amount to £1,942 50 plus disbursements of £78. My agents outstanding fees will be met from the Administration funds in due course. The agents' fees are being regularly reviewed as part of the strategic review of the case.

7. ENDING OF ADMINISTRATIONS

- As it is anticipated there will be insufficient property in the Companies to enable a distribution to unsecured creditors, it is inappropriate to proceed to Liquidation. In accordance with my proposals dated 22 July 2011, it is proposed that once all Companies assets have been realised and the expenses of the Administration discharged, the Companies shall be dissolved.
- 7 2 In accordance with rule 2 33(m) of the Rules, I will seek my discharge by lodging a final notice at Companies House The Companies will be deemed dissolved three months after the notice is received by Companies House, unless challenged
