UPON THE APPLICATION of the Applicants dated 2nd August 2018 for an order under Rule 12.36 of the Insolvency Rules 2016 (the "Application") to remove the Respondent (the "Outgoing Office-holder") from the insolvency offices held by him in the attached Schedule to this Order (together the "Insolvency Proceedings") and to replace him as office-holder with the Applicants as listed in the attached Schedule (the "Replacement Office-holders").

- 3. In respect of the members' voluntary liquidations listed in Part B of the Schedule, pursuant to sections 108 of the Insolvency Act 1986, the Outgoing Office-holder is removed as joint liquidator and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
- 4. In respect of company voluntary arrangements listed in Part C of the Schedule, pursuant to sections 7(5) and paragraph 39(6) of Schedule A1 to the Insolvency Act 1986, the Outgoing Office-holder is removed as joint supervisor and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
- 5. In respect of the partnership voluntary arrangement listed in Part D of the Schedule, pursuant to sections 7(5) and paragraph 39(6) of Schedule A1 to the insolvency Act 1986 (as amended and applied to partnerships by the insolvent Partnership Regulations 1994), the Outgoing Office-holder is removed as joint supervisor and Lisa Alford is appointed in his place.

- 6. In respect of the bankruptcies listed in Part E of the Schedule, pursuant to sections 298 of the Insolvency Act 1986 and Rule 12.36(2) of the Insolvency Rules 2016, the Outgoing Office-holder is removed as joint trustee in bankruptcy and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
- 7. In respect of individual voluntary arrangements listed in Part F of the Schedule, pursuant to section 263(5) of the Insolvency Act 1986, the Outgoing Office-holder is removed as joint supervisor and the relevant Replacement Office-holder as set out in the Schedule is appointed in his place.
- 8. In respect of individual voluntary arrangement listed in Part G of the Schedule, pursuant to section 256A(4) of the Insolvency Act 1986, the Outgoing Office-holder is removed as joint nominee and Christopher Parkman is appointed in his place.
- 9. The Applicants shall as soon as practicable (and in any event within 30 days of the date of this Order) give notice of this Order and the removal of the Outgoing Office-holder and the appointment of the Replacement Office-holders to the Secretary of State and to each of the creditors in respect of each of the Insolvency Proceedings together with, as appropriate, each debtor, bankrupt or the Registrar of Companies.
- 10. Each creditor may apply (within 14 days of the creditor being given notice of this Order) to vary or discharge this Order but only in so far as it relates to the Insolvency Proceeding of which they are a creditor.
- 11. The costs of and incidental to the Application (the "Costs") shall be expenses of each of the Insolvency Proceedings.
- 12. Each of the Insolvency Proceedings is to bear an equal proportion of the Costs save that, in so far as any particular insolvent estate may have insufficient funds or immediately realisable assets to meet its proportionate share of the Costs, the Applicants are to agree on the apportionment of the Costs and may make such adjustment between the insolvent estates as may be necessary to enable the Costs to be paid.
