DRAFT ORDER

BEFORE District Judge Coldings sitting as a Judge of the High Court on 29 \ 2016

UPON the Application of Steven Wiseglass, Licensed Insolvency Practitioner of Inquesta Limited, 15 New Rd, Manchester M26 1LS.

AND UPON reading the evidence and the documents filed with this Court

IT IS HEREBY ORDERED THAT:

- 1 That any case listed in the attached 3 schedules being under the jurisdiction of the County Court be transferred to the High Court for the purpose only of making this order.
- That the Respondent be removed from office in respect of the cases listed at Schedule 1 hereto and that the Applicant be appointed Liquidator in substitution.

- That the Respondent be removed from office in respect of the cases listed at Schedule
 hereto and that the Applicant be appointed as Supervisor in substitution
- 4. That the Respondent be removed from office in respect of the cases listed at Schedule 3 hereto and that the Applicant be appointed as Trustee in bankruptcy in substitution.
- 5. Each creditor is to be informed by letter of the terms of this order within 28 days of the date of this order indicating specifically the terms of paragraph 6 below.
- 6 Any creditor in respect of any of the cases to have liberty to apply for review of this Order within 28 days of the receipt by the creditor of a letter referred to in paragraph 5 above.
- 7 The costs of and occasioned by the Application (including VAT) be aggregated and appointed equally between each of the cases listed in the said Schedules to this Application provided that.
 - a. Should the costs which fall to be borne by any of the estates in any of the Cases exceed 10% of the realisable assets within that estate then;
 - b. The estate shall only bear of those appointed costs, that part being an amount equal to 10% of that estate's readily realizable assets; and

- c. the excess shall then be apportioned and borne equally between the other estates.
- 8 Any remuneration restriction that may have been put in place by creditors in any particular case may be disregarded by the Applicant and the above costs may be borne by the estate of such cases in addition to any maximum amount of remuneration authorised by creditors.

9. That such cases as were transferred under paragraph 1 above be transferred back to their original courts.
