

1. As a continuing security for payment of the Secured Liabilities, each Chargor with full title guarantee charged to the Security Trustee all its right, title and interest from time to time in each of the following assets -

1.1 by way of first legal mortgage all Land which is described in Schedule 1 (see below) and all other Land now vested in such Chargor at the date of the Debenture;

- (i) its present and future goodwill and uncalled capital of each Chargor at the date of the Debenture and thereafter.

2. As continuing security for payment of the Secured Liabilities, each Chargor with full title guarantee charges by way of first floating charge the whole of such Chargor's undertaking and assets, present and future and wherever situated, which are not for any reason effectively charged (whether in law or equity) by way of fixed security by the Deed, including, without limitation, any heritable property of such Chargor situated in Scotland.

3. If or to the extent that for any reason the assignment or charging of any Charged Property is prohibited, such Chargor shall hold it on trust for the Security Agent.
