**1 Statutory information**

Woodstock Recordings Ltd is a private company, limited by shares, registered in England and Wales, registration number 07302575. The registered office is 4 JUPITER COURT, 10 - 12 TOLWORTH RISE SOUTH, SURBITON, SURREY, KT5 9NN.

**2 Compliance with accounting standards**

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

**3 Accounting policies**

The principal accounting policies adopted in the preparation of the financial statements are set out below and have remained unchanged from the previous year, and also have been consistently applied within the same accounts.

***Basis of preparation***

The accounts have been prepared under the historical cost convention as modified by the revaluation of certain fixed assets.

***Presentation currency***

The accounts are presented in £ sterling.

***Going concern***

The financial statements are prepared on the going concern basis. The director and shareholder has confirmed that a related company, La Lennox Limited, will continue to support the company for the foreseeable future.

***Cash and cash equivalents***

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours.

***Creditors***

Short term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.
