UPON THE APPLICATION for a block transfer order pursuant to Rule 12.36 of the Insolvency (England and Wales) Rules 2016

AND UPON READING the witness statement of the Applicant and the witness statements of the Respondents consenting to the Application

AND UPON READING the Skeleton Argument filed on behalf of the Applicant

AND UPON READING an email from the Insolvency Service dated 5 April 2022 confirming that neither the Secretary of State nor the Official Receiver object to the Application

IT IS ORDERED THAT: -

- 1. In respect of the Bankruptcy, Compulsory Liquidation, Creditors' Voluntary Liquidations ("CVLs") and Members' Voluntary Liquidations ("MVLs") listed in Schedules 1 to 4 attached to the application ("the Schedules") which are the subject of proceedings in the County Court or High Court, those proceedings be transferred to the Business and Property Courts in Leeds, solely for the purpose of hearing the application for the Orders contained in paragraphs 2 to 8 below.
- 2. The Applicant be removed from office as Trustee in Bankruptcy of the individual listed in Schedule 1, for which he is the Joint Appointee, which will be transferred to the relevant Respondent shown in the Schedule with immediate effect, who is to act alongside the existing Joint Appointee with authority to act jointly and severally.
- 3. The Applicant be removed from office as Liquidator (both Compulsory and Voluntary) of the estates of the companies for which he is the Joint Appointee listed in Schedules 2 to 4 which will be transferred to the relevant Respondent shown in the Schedules with immediate effect, who is to act alongside the existing Joint Appointee with authority to act jointly and severally.
- 4. The Applicant be replaced as such office holder in the case of each such estate by the Respondents named in the Schedules as his proposed replacement, these replacements to take effect within the timescales referred to at paragraphs 2 to 3 above.
- 5. The Respondents shall be entitled to:-
 - 5.1 Publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette; and

- 5.2 Charge to each individual estate the costs of obtaining an Insolvency Practitioner's licence bond in respect of that estate.
- 6. The Applicant shall be granted his release as appropriate 7 days after the publication of the notice in the Gazette referred to at paragraph 5.1 above.
- 7. Pursuant to Rule 12.38(6)(b) of the Insolvency (England and Wales) Rules 2016 and with a view to avoiding unnecessary additional expenses to any of the said estates, the Respondents shall only be required to deliver notice to creditors of the making of this Order when the next routine report is due to the creditors of each estate. Such notice shall contain express reference to the liberty to apply in paragraph 8 below.
- 8. Liberty to each creditor of each estate to apply to vary or discharge this Order within 7 days of receipt of the notices directed to be sent under paragraph 7 above.
- 9. An Order that following the Orders made in paragraphs 2 to 8 above, the Bankruptcy, Compulsory Liquidation, CVLs and MVLs referred to in the Schedules be transferred back to the Court or hearing centre from which they were transferred.
- 10. Service of the said Application Notice be dispensed with.
