#### ARTICLES OF ASSOCIATION

of

#### ABAKUS (REJZA) LIMITED ("the Company")

#### 1. Interpretation

In these Articles, if not inconsistent with the subject or context

'the Act' means the provisions of the Companies Act 2006 as amended and in force prior to the adoption of the Articles,

'Model Articles' means the model articles for private companies limited by shares contained in Schedule 1 of the Companies (Model Articles) Regulations 2008 (SI 2008/3229) as amended prior to the date of adoption of these Articles and

words and expressions which have a particular meaning in the Model Articles shall have the same meaning in these Articles

#### 2. Model Articles

- 2.1 The Model Articles apply to the Company except in so far as they are excluded or modified by or are inconsistent with these Articles
- 2 2 Article 14 of the Model Articles shall not apply to the Company

#### 3. Interested Directors permitted to vote

Subject to disclosure in accordance with section 177 or section 182 of the Act (as applicable), a director shall be entitled to vote and to form part of the quorum at a meeting of directors or of a committee of directors on any resolution concerning a matter in which he has an interest

#### 4. Company Secretary

The directors may appoint any person who is willing to act as the secretary for such term, at such remuneration and upon such conditions as they may think fit and from time to time remove such person and, if the directors so decide, appoint a replacement in each case by a decision of the directors
