Charge

As continuing security for the payment of the Secured Liabilities, the Chargor charges in favour of T&G by way of fixed charge all its present and future rights, title and interest in and to the Deposits including, without limitation, the claim of the Chargor to repayment thereof (the "Charged Property")

Note, inter alia, the pursuant to the Charge

- (a) The Chargor shall not without the prior written consent of T&G create or permit to subsist or arise any Security over the Charged Property
- (b) Subject to paragraph (a) above, any Security on the Charged Property created in the future by the Chargor (otherwise than in favour of T&G) shall be expressed due to the subject of the Charge
