Special Resolutions

1. 4. As an ordinary resolution in accordance with section 282 of the Companies Act 2006 THAT the reasonable disbursements of the joint liquidators, including those defined as Category 2 disbursements in Statement of Insolvency Practice No. 9, be paid.

Information required to comply with section 291(4) of the Companies Act 2006

- a) Eligible members are the members who would have been entitled to vote on the resolutions on the circulation date of the written resolutions.
- b) The procedure for signifying agreement by an eligible member to written resolution is as follows:
 - o A member signifies his agreement to a proposed written resolution when the Company receives from him (or someone acting on his behalf) an authenticated document identifying the resolutions to which it relates, and indicating his agreement to the resolution.
 - o The document must be sent to the Company in hard copy form or in electronic form.
 - o A member's agreement to a written resolution, once signified, may not be revoked.
 - o A written resolution is passed when the required majority of eligible members have signified their agreement to it.
- c) The period for agreeing to the written resolutions is the period of 28 days beginning with the circulation date (see section 297 of the Companies Act 2006).




