Notes to Statement of Affairs

[20 December 2021]

1. Cash at bank:

- 1.1 Is stated as at 17 December 2021.
- 1.2 There are further payments to be made, such as wages, which will reduce the bank balance until the point of Liquidation.

2. Tangible Assets:

- 2.1 The tangible assets (at Nil value in the books and records) have not yet been formally valued but are considered to be of limited value only.
- These assets will be valued in the Liquidation and realised if not needed in the orderly wind down of the Company's affairs. A nominal value of £1,000 has been given for the purposes of this report.

3. **Debtors:**

- 3.1 Given the time passed, all accounts are now in arrears.
- 3.2 The figure for future realisations is made from estimated recoveries provided by debt collection agencies retained by the Company to collect the outstanding ledger.

4. Ferratum claim:

- 4.1 As set out in the main body of the report, Ferratum (the previous owner) has substantially supported the Company in the past through funding trading.
- 4.2 The balance due to Ferratum was converted to share capital in October 2021 and the remaining balance is now some £1.589M.

5. Redress:

- There have been a range of figures produced to estimate the Redress balance due to customers; the range is from £ 3.4M to £50M depending on the methodology used.
- 5.2 Until further work is done, a more accurate value is not currently available. The Redress liability will be substantial.

6. Other Creditors:

- 6.1 The other creditors (to include HMRC) are up to date and within credit terms.
- 6.2 The employees will be paid up to the 31 December 2021.
- 6.3 It is probable that there will be some (relatively small) accrued liability to HMRC at the point of Liquidation. That claim will be Preferential. For the purposes of the Statement of Affairs, a nominal £1 only is included in the creditor figures. This will be subject to review and agreement with any subsequently appointed Liquidator.
