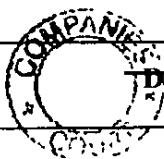

COMPANIES HOUSE

- 1 The cases set out in the Schedules hereto and referred to as being in the county court or (if appropriate) being cases in a District Registry ("the other courts") be transferred to the Companies Court for the purpose of this Application and be transferred back upon the making of this Order.
2. In relation to the administrations of The Epsom Legion Club Limited and Michael John Design Limited identified in Schedule A to this order, Grant Lane Pegg be removed as the Joint Administrator.
3. In relation to the bankruptcies identified in Schedule B to this order, Grant Lane Pegg be removed as the Joint Trustee.
- 4 In relation to the creditors' voluntary liquidations identified in Schedule C1 to this order, Grant Lane Pegg be removed as the Joint Liquidator.
5. In relation to the creditors' voluntary liquidations identified in Schedule C2 to this order, Grant Lane Pegg be removed as the Liquidator and David Frank Perkins be appointed in his place.
- 6 In relation to the members' voluntary liquidations identified in Schedule D1 to this order, Grant Lane Pegg be removed as the Joint Liquidator.
- 7 In relation to the members' voluntary liquidations identified in Schedule D2 to this order, Grant Lane Pegg be removed as the Liquidator and David Frank Perkins be appointed in his place
8. In relation to the compulsory liquidation of Karden (UK) Limited identified in Schedule E to this order, Grant Lane Pegg be removed as the Joint Liquidator.
9. In respect of all matters set out in the Schedule to this order there shall be no requirement for progress reports or receipts and payments accounts to be prepared or filed by virtue of Grant Lane Pegg vacating office in accordance with this order. For the avoidance of doubt the provisions of Rules 2.47(3A), 6.78(A)4, 4.49B(5) and 4.49(C) – CVL(3)(a)-(b) shall not apply in respect of the matters which are the subject of this order.
10. Each creditor and, in the case of the members' voluntary liquidations, each member, shall have permission to apply to vary or discharge this order in whole or in part within 28 days of being given notice of it under paragraph 11 below.
11. Where the Insolvency Act 1986 or the Insolvency Rules 1986 require the substitution or removal of Grant Lane Pegg to be advertised, the Applicants shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, the block advertisement in relation to each of the estates shall be placed in the London Gazette containing notification of the following matters:
 - a) the substitution of Grant Lane Pegg and details of the substitution;

- b) the fact that creditors have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge the order made;
 - c) in the case of each bankruptcy and liquidation, that.
 - i) the cost of complying with a request of the committee or creditor for an account of Grant Lane Pegg's administration should be an expense of the insolvency proceedings;
 - ii) the fact that Grant Lane Pegg will be entitled to apply to the Secretary of State for his release within 42 days after the notice has been advertised.
- 12 As soon as reasonably practicable, the Applicants shall lodge with each of the other courts one copy of this Order for each case under the jurisdiction for filing on the respective court file.
