The Owner will pay to the Bank on demand all the Owner's Obligations. The Owner's Obligations are all the Owner's liabilities to the Bank (present, future, actual or contingent and

- Interest at the rate charged by the Bank, calculated both before and after demand or 1.1 judgment on a daily basis and compounded according to agreement, or, in the absence of agreement, quarterly on the days selected by the Bank.
- any expenses the Bank or a receiver incurs (on a full indemnity basis and with Interest from 1.2 1.2.1
- the Property charged by Clause 2. References to Property include any part of it. 1.2.2
- taking, perfecting, protecting, enforcing or exercising any power under this deed. 2.

The Owner, as a continuing security for the payment on demand of the Owner's Obligations and with full title guarantee, gives to the Bank:

- dispose of, part with or share possession or occupation of any of its Land.
