IT IS ORDERED THAT Future Carbon Ltd be wound-up by this Court under the provisions of the Insolvency Act 1986

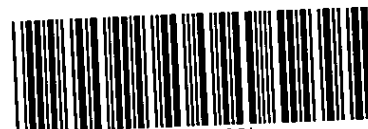
AND IT IS ORDERED THAT the costs of the Petitioner of the Petition be paid out of the assets of the Company
