#### LAVENDER GARDENS RESIDENTS LIMITED

#### **Preliminary**

In these Articles, except where the context otherwise required, the following words shall have the following meanings -

"the Act" means the Companies Act 2006, but so that any reference in these Articles to any provision of the Act shall be deemed to include a reference to any statutory modification or re-enactment of that provision for the time being in force,

"the Developer" means Martin Grant Homes Limited or other freeholder for the time being of the Estate,

"the Estate" means the residential development comprising thirteen freehold properties now developed or in the course of development at Lavender Gardens, Clayhanger, Guildford GU4 7XT by the Developer and includes all the land comprised in the Estate,

"Owner" means the owner for the time being of a Unit,

"Subscribers" means the subscribers to these Articles,

"the Ultimate Date" means the first anniversary of the earliest date on which no Unit remains to be sold (meaning by way of a transfer of the freehold estate in the case of a dwellinghouse or by way of the grant of a lease/an underlease in the case of a flat/maisonette (as the case may be)),

"Unit" means a freehold dwellinghouse or a flat/maisonette (as the case may be) on the Estate,

- The model articles of association for private companies limited by shares contained in Schedule 1 to the Companies (Model Articles) Regulations 2008 (SI 2008 No 3229) (the "Model Articles") shall apply to the Company save in so far as they are excluded or modified hereby and such Model Articles and the articles set out below shall be the Articles of Association of the Company (the "Articles")
- Model Articles 19, 20, 22, 26(2), 30 and 36 shall not apply to the Company

#### **Objects**

- 4. The Company's objects are:
- 4.1 To manage and maintain the Estate
- 4 2 To exercise the functions of a residents association and management company formed to safeguard and promote the common interests of the residents of and to manage the Estate
- To purchase, take on lease or in exchange, hire or otherwise acquire any real or personal property and any rights or privileges which the Company may think necessary or convenient for the promotion of its objects, and to construct maintain and alter any buildings or erections and layout, maintain and use roads, paths, ways, drives, forecourts, gardens and amenity grounds, and construct acquire and use installations, equipment and communal services of all kinds for the benefit of the residents of the Estate
- To sell, let, mortgage, dispose of or turn to account all or any of the property or assets of the Company as may be thought expedient with a view to the promotion of its objects
- 4.5 To borrow or raise money for the purposes of the Company on such terms and on such security as may be thought fit
- To invest the monies of the Company not immediately required for its purposes in or upon such investments, securities or property as may be thought fit.

- To establish and support or aid in the establishment and support of any charitable associations or institutions and to subscribe or guarantee money for charitable purposes in any way connected with the purposes of the Company or calculated to further its objects
- 4 8 To do all such other things as are incidental or conductive to the attainment of the above objects or any of them

#### Shares

- The share capital of the Company is £15 00 divided into two founder shares of One Pound each and thirteen ordinary shares of One Pound each
- No person except an Owner shall be registered as the holder of an ordinary share and no Owner shall be registered as the holder of more than one ordinary share for each Unit of which he is the Owner. Where two or more persons together are the Owner they shall together constitute one member and the person whose name first appears on the register of members shall exercise the voting and any other powers vested in such member.
- A transfer of an ordinary or founder share or shares (as the case may be) shall not be at a price in excess of the nominal value of the share(s)
- 6. The directors shall be bound to register:-
- a transfer of a share by an Owner to a transferee of his Unit.
- as a member (1) the first Owner of a Unit and (11) any person who has by reason of the death bankruptcy or insolvency of a member become entitled to the member's share and has had vested in him the member's Unit
- 6.3 a transfer of a founder share or shares by a subscriber either to the Developer or to an Owner
- a transfer by a mortgagee of a share to a purchaser from such mortgagee under his power of sale of the Unit in respect of which such share was charged to the mortgagee.
- If a member fails to transfer his share to a transferee of the Unit of which he is the Owner within one month of the said transfer of the Unit the directors shall be entitled, by

resolution, to appoint some person to be the Attorney of such member to execute a transfer of such share to such transferee for its nominal value and the Company shall, upon receiving the purchase price from the transferee (if demanded), register such transfer and thereupon the transferee shall become a member in place of the previous holder of such share

8. On a winding up a holder of a founder share shall not by virtue of such holding be entitled to any share of the surplus assets of the Company which shall belong exclusively to the holders of the ordinary shares

#### Sections 550, 561, 562 and 567 of the Act

- 9. In accordance with Section 567 of the Act Sections 561 and 562 of the said Act shall not apply to the Company
- 9 1 The directors are generally and unconditionally authorised for the purposes of Section 550 of the Act, to exercise any power of the Company to allot and grant rights to subscribe for or convert securities into shares of the Company up to the amount of the authorised share capital with which the Company is incorporated at any time or times during the period of five years from the date of incorporation and the directors may, after that period, allot any shares or grant any such rights under this authority in pursuance of an offer or agreement so to do made by the Company within that period. The authority hereby given may at any time (subject to the said Section 550) be renewed, revoked or varied by Ordinary Resolution.

#### **Directors**

- Until the Company shall by resolution otherwise determine, the number of directors shall not be less than two nor more than seven The first directors shall be appointed by the Subscribers
- No person (unless appointed by the holders of the founder shares or co-opted by the directors before the Ultimate Date) shall be eligible to be a director, unless he holds at least one ordinary share

The directors for the time being shall in any event retire at the annual general meeting held next after the Ultimate Date and, until the date of such meeting, the holders for the time being of a majority of holders of the founder shares may, by notice in writing, remove any director from office and may by a like notice appoint any person to be a director

#### Votes of Members

- Unless the holders of the founder shares shall have resigned prior to the Ultimate Date, until the Ultimate Date the holder of any ordinary share shall not by virtue of such holding be entitled to receive notice of or to attend or vote at any General Meeting of the Company
- Unless the holders of the founder shares shall have resigned prior to the Ultimate Date, then following the Ultimate Date every holder of an ordinary share shall be entitled to one vote at a General Meeting for each share held by him, but a holder of a founder share shall not by virtue of such holding be entitled to receive notice of or attend or vote at any General Meeting of the Company

#### **Proceedings of Directors**

- A director may vote, at any meeting of the directors or of any committee of the directors, on any resolution, notwithstanding that it in any way concerns or relates to a matter in which he has, directly or indirectly, any kind of interest whatsoever, and if he shall vote on any such resolution his vote shall be counted; and in relation to any such resolution as aforesaid he shall (whether or not he shall vote on the same) be taken into account in calculating the quorum present at the meeting, and Model Article 11 shall be modified accordingly
- Each director shall comply with his obligations to disclose his interest in contracts under Section 177 of the Act.
