#### IT IS ORDERED that:-

#### Transfer in of cases

The cases listed in the schedules attached hereto insofar as they are currently proceedings in a County Court, High Court or in another District Registry be transferred to the Birmingham District Registry for the purpose of making the Orders listed below

Removals and Appointments

- In relation to the administrations identified in schedule A hereto, the Respondent be removed from office as Administrator of the companies in administration and the Applicant be appointed as Administrator of the same in his place with effect from the date of this Order
- In relation to all the bankruptcies set out in Schedule B hereto, the Respondent be removed from office as Trustee in Bankruptcy and the Applicant be appointed in his place with effect from the date of this Order
- In relation to the compulsory winding up set out in Schedule C hereto, the Respondent be removed from office as Liquidator and the Applicant be appointed in his place with effect from the date of this Order
- In relation to all the Creditors' Voluntary Liquidations set out in schedule D hereto, the Respondent be removed from office as Liquidator of the companies in liquidation and the Applicant be appointed Liquidator of the same in his place with effect from the date of this Order
- In relation to all the voluntary arrangements set out in Schedule E hereto, the Respondent be removed from office as Supervisor and the Applicant be appointed in his place with effect from the date of this Order

#### Notice of the Order

- 7 The Applicant shall give notice of this Order to all creditors of the estates listed in the schedules within twenty-eight days from the date of this Order, either by letter or by means of an advertisement in the London Gazette
- 3 The Applicant shall notify the Secretary of State of the Order as soon as reasonably practicable after it is made.
