IT IS ORDERED THAT

1 TRANSFER BETWEEN COURTS

- 1.1 The cases set out in the Schedules to this Order ("the Schedules") are hereby transferred to this Court pursuant to Rule 7 10C(1)(a) Insolvency Rules 1986 ("IR86"), for the purposes of the following paragraphs of this Order

2 APPLICANT'S REMOVAL AS OFFICEHOLDER

2.1 Pursuant to the relevant power sets out in 2.2 below out below

- 2.1.1 Simon Guy Campbell shall be removed as office holder in the cases set out in Schedules 1, 2, 3, and 4 with effect from the date of this Order,
2.1.2 Carolyn Meister shall be removed as office holder in the cases set out in Schedule 5 with effect from the date of this Order,

2.2 The office holders shall be removed from office pursuant to the following powers

- 2 2 1 Administration - Paragraph 88 Schedule B1 Insolvency Act 1986 ("IA86") and Rule 7 10B(2)(b) IR86,
- 2 2 2 Bankruptcy - Section 298 IA86 and Rule 7 10B(2)(c) IR86,
- 2 2 3 Creditors Voluntary Liquidation - Section 171(2) IA86 and Rule 7 10B(2)(a) IR86,
- 2 2 4 Compulsory Liquidation - Section 172(2) IA86 and Rule 7 10B(2)(a) IR86, and
- 2 2 5 Individual Voluntary Arrangements - Section 256(3) IA86 and Rule 7 10B(2)(d) IR86
- 2 2 6 Partnership Voluntary Arrangements - Sections 256(3) IA86 (as applied and applied by Section 4 Insolvent Partnerships Order (as amended))

3. APPOINTMENT OF OFFICEHOLDERS

- 3 1 Sally Richard shall be appointed in substitution of the Simon Guy Campbell as the joint office holder together with Julie Anne Palmer in respect of the matters listed in Schedule 1 to this Order
- 3 2 Sally Richards shall be appointed in substitution of Simon Guy Campbell as the joint office holder together with Jamie Taylor in respect of the matters listed in Schedule 2 to this Order
- 3 3 Sally Richards shall be appointed in substitution of the Simon Guy Campbell as the joint office holder together with Neil Frank Vinnicombe in respect of the matters listed in Schedule 3 to this Order
- 3 4 Simon Guy Campbell shall resign as office holder in respect of the matters listed in Schedule 4 to this Order, leaving Julie Anne Palmer and Francis Gavin Savage as joint office holders
- 3 5 Each of Julie Anne Palmer and Sally Richards shall be appointed as joint office holders in substitution of Carolyn Meister in respect of the matters listed in Schedule 5 to this Order
- 3 6 The appointments of each of Julie Anne Palmer and Sally Richards (the "Incoming Office Holder") set out above shall take effect from the date of this Order

~~3 6 3 7~~ For the purpose of rule 2 117A(2) IR86 where Simon Guy Campbell is duly nominated to act as a Liquidator, the Incoming Office Holder or each of them shall be deemed nominated in substitution of Simon Guy Campbell

4. REPORTING

- 4 1 The Incoming Office Holder or Joint office holder shall attach a copy of this Order to the next statutory report for each insolvency administration listed in the Schedules, or
- 4 2. The removal and appointments granted by this Order shall not disturb the existing reporting cycle for each of the respective insolvency appointments listed in the Schedules and the current time limit for reporting to creditors on each of the insolvency appointments shall continue irrespective of the removal and appointments made by this Order
- 4 3 The provisions contained in Insolvency Rules 2.47(3A), 4 49B(5), 4 49C(3) and 6 78A(4) of the Insolvency Rules 1986 or any other such reporting requirements shall not apply and neither Simon Guy Campbell nor Carolyn Meister is required to produce any progress reports on ceasing to act as office holder of the insolvency appointments listed in the Schedules
- 4 4 That an extension of time for the filing of Progress Reports shall be triggered by this Order pursuant to Rule 4, Rule 4 3, Rule 4 49B(8) and Rule 6 78A(7) IR86 so that the making of this Block Transfer Order does not trigger the production of a further Progress Report and instead



an extension of time is granted that has the effect of preserving the current anniversary dates of the respective Administrations, Liquidations and Bankruptcies

- 4 5 Neither Simon Guy Campbell nor Carolyn Meister shall be required to submit a D Report in respect of any of the Voluntary Liquidations listed in the Schedules pursuant to Rule 4(5)(b) Insolvent Companies (Report on Conduct of Directors) Rules 1996 and such reporting obligations shall be carried out by the Incoming Insolvency Practitioner as required in each case

5 SERVICE ADVERTISEMENT AND REPORTING TO CREDITORS

- 5 1 As soon as reasonably practicable, the Incoming Office Holder or joint office holder shall file with each of the applicable courts mentioned in the schedules hereto one copy of this Order for each case for filing on the Court file relating to that case

- 5 2 Under Rule 7 10D(6) IR86 (as amended) the Incoming Office Holder or joint office holder of the respective estates shall be notified of the effect of this Order by one advert in the London Gazette within 28 days of the date of this Order

- 5 3 Any creditor (or members in the case of members' voluntary liquidations) who objects to the transfer of an insolvency appointment as provided by this Order shall have a period of 28 days from the date of the advert to apply to court to set aside or vary the terms of this Order. However, such application shall not affect the transfer of the insolvency appointments by this Order until further or other order by the court

6 RELEASE

- 6 1 Each of Simon Guy Campbell and Carolyn Meister shall receive their release as Administrator, Supervisor, Liquidator, Trustee or joint Supervisor, joint Administrator, joint Liquidator and joint Trustee 14 days after the advert is placed in the London Gazette, save that such release may be subject to further order in the event of an application by any creditor as referred to at paragraph 5 3 above for the specific case subject to that application

7 TRANSFER BETWEEN COURTS

- 7 1 The cases specified in the Schedules of cases above are hereby transferred back to the County Court or District Registry from which they were transferred by the Order made in paragraph 1 above, adopting the same case numbers used immediately before their transfer to the Bristol District Registry
