NAVIGO HEALTH AND SOCIAL CARE CIC STRATEGIC REPORT FOR THE YEAR ENDED 31 MARCH 2014

This is the third period of trading following incorporation. In the final year of our three year contract with our main NHS Commissioner, the company has been able to further develop its business both in line with our stated aims and has taken opportunities to further the business where potential has been identified. This has enabled the organisation to secure a further three year contract with our main commissioner as well as increasing our activities with regional Commissioners, all meaning the financial health of the organisation is positive for the future.

In terms of performance in the year, the organisation has achieved the vast majority of targets both determined through NHS contracts and those developed internally. As we remain predominantly NHS funded, we retain the statutory obligation to report Quality Accounts on an annual basis and our detailed performance against targets is reported through that mechanism. At quarter four 2013/14 we reported that out of 35 national Performance Indicators required within our contract, NAViGO achieved 29 (82 9%) on or above target (green), 4 (11 4%) slightly below target (amber) and 2 (5 7%) below target (red)

Of the indicators where benchmarking is available, we are above or equal to the England average for 88% of the indicators (22/25) We remain in the top quartile of organisations in England for service users in both employment and settled accommodation

In addition to the national performance indicators mandated in our contract, we are also in the top 25% of trusts for 67% (6/9) of PbR outcome measures showing our readiness to comply with these indicators once they become mandated

The work of NAViGO as both an organisation and a provider of quality services has been recognised again this year by the CQC who inspected our registered premises and rated NAViGO compliant in the outcomes inspected which were

- · Consent to care and treatment
- Care and welfare of people who use services
- Cleanliness and infection control
- · Requirements relating to workers
- Complaints

In addition to the CQC's endorsement of services, NAViGO's Community Mental Health Team Memory Service were accredited as excellent for the provision of assessment and diagnosis of dementia and excellent for the provision of psychosocial interventions for dementia by the Royal College of Psychiatrists

Our RESPECT Training Solutions have once again received accreditation by BILD (the British Institute of Learning Disabilities)

We have been nominated for a host of local, regional and national awards once again in 2013/14 and were successful in winning two national awards. A member of staff won the prestigious Award for Innovation managed by Medipex and the whole organisation won the Service of the Year award at the GO Public Procurement awards. Our Eating Disorder services and Open Minds services were also creditable finalists in specialist awards in their respective fields.

Alongside this, NAViGO's staff survey showed that the organisation is one of the highest performing health organisations in the UK. Data showed that NAViGO is the top performer in an astonishing 65% of questions asked 73% of staff said that they would recommend NAViGO as a place to work, this compares to a national average of just 45%

We were above the national average on all 15 questions in the survey that related to service user experience 79% of staff agreed that the organisation has a clear vision for the future, 31% higher than the national average

Financially, the organisation has benefitted from grant awards in year and continued close monitoring of financial risks has helped to contribute to a strategic reserve that enables us to plan for the future with more confidence. Of the identified financial risks, few materialised in the year and therefore finances have performed well. This has put us on a firm footing to approach our new NHS contract. Our reserves are critical to the overall financial sustainability of the organisation as we remain unsure about the future of public finances even within our current contract.

In the future NAViGO faces those risks commensurate with a continued challenging economic climate, particularly as the company is almost solely funded through public sector contracts, however the organisation remains ambitious and continues to look for new opportunities to enhance our offer to the local community of whom we wish to serve

The directors present their report and financial statements for the year ended 31 March 2014

PRINCIPAL ACTIVITY

The principal activities of the company in the year are those most commonly associated with a provider of Mental Healthcare services. The vast majority of the services provided are via NHS contracts with local and regional Commissioners. NAViGO provides community health and care services in a variety of settings, including people's homes, GP practices and community-based buildings as well as impatient settings. Our focus is on care delivered as far as possible in real-life settings—and the integration of care with the daily lives of our users. Our philosophy is to develop services in close working relationships with service users and their families and carers. Some of our activities include—

- Services for people with common mental health problems
- In-patient, crisis and home support
- Services for people with dementia
- Eating disorder services
- Support in the community
- Employment & training

Most people who use our services will continue to access them through the NHS, however more and more of our services are recognizing the need to trade directly with the public NAViGO is about continuing to improve the mental health and social care services that the people of North East Lincolnshire have come to expect innovative services in a variety of settings

We will continue to work hard with our community to not only provide dynamic, innovative services, but to also break down the stigma and discrimination that is sometimes associated with mental health illnesses

Yet again in 2013/14 we have won national awards for some of our innovative and novel approaches to delivering services. Some of our "back office" functions have also performed exceptionally well, winning a national award for our approach to procurement.

Many of our services go beyond mental health into a variety of care settings, working with a varied cross section of people including people with learning disabilities, people with employment issues, young people striving to get a foothold in life and people who are simply adapting to life as older people

NAViGO continues a tradition of a healthcare organisation based on people with powerful values rooted in commitment to our service users. These values will continue to inform and guide the work of our organisation as a social enterprise. We seek to provide services in partnership with the people who know our services best, our service users and staff

1. AUTHORISATION OF FINANCIAL STATEMENTS AND STATEMENT OF COMPLIANCE WITH IFRS'S

The company's financial statements for the year were authorised for issue on 25 June 2014 and the statement of financial position signed on the board's behalf by S J Beeton Navigo Health and Social Care CIC is a limited company incorporated and domiciled in England & Wales

The company's financial statements have been prepared in accordance with International Financial Reporting Standards (IFRSs) as adopted by the European Union and as applied in accordance with the provisions of the Companies Act 2006. The principal accounting policies adopted by the company are set out in note 2

2. ACCOUNTING POLICIES

Revenue recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the company and the revenue can be reliably measured. All such revenue is reported net of discounts and value added and other sales taxes

Interest income

Interest income is accrued on a time basis and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount

Income tax

Income tax expense represents the sum of the tax currently payable and deferred income tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from net profit as reported in the income statement because it excludes items of income or expense that are taxable or deductible in other years and it furthers excludes items that are never taxable or deductible. The company's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the statement of financial position date.

Property, plant and equipment

Items of property, plant and equipment are stated at cost of acquisition or production cost less accumulated depreciation and impairment losses

Depreciation is charged so as to write off the cost or valuation of assets over their estimated useful lives with no depreciation in the year of acquisition and a full year of depreciation in the year of disposal, using the straight line method, on the following bases

Freehold property 2% per annum
Motor vehicles 25% per annum
Fixtures and fittings 25% per annum

2. ACCOUNTING POLICIES (continued)

Financial risk management objectives and policies

The objective of the company's capital management is to ensure that it maintains strong credit ratings and capital ratios. This will ensure that the business is correctly supported

Inventories

Inventories are valued at the lower of cost and net realisable value

Net realisable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and the estimated costs necessary to make the sale

Trade and other receivables

Trade and other receivables are recognised by the company and carried at original invoice amount less an allowance for any uncollectible or impaired amounts

An estimate for doubtful debts is made when collection of the full amount is no longer probable. Bad debts are written off when they are identified as being bad

Other receivables are recognised at fair value

Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and in hand and short term deposits. Short term deposits are defined as deposits with an initial maturity of three months or less

Deferred tax

Deferred tax is provided in full, using the statement of financial position liability method, on temporary differences arising between the tax bases of assets and liabilities and the carrying amounts in the financial statements

Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that future taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than as a business combination) or other assets and liabilities in a transaction that affects neither the tax profit nor the accounting profit

Deferred tax is determined using the tax rates that are expected to apply in the period when the asset is realised or the liability is settled

Trade and other payables

Trade and other payables are initially measured at fair value, and are subsequently measured at amortised cost, using the effective interest rate method

Operating lease commitments

Operating leases payments are recognised as an expense in the income statement on a straight-line basis over the lease term

The Membership (Staff, Service Users and Carers) have been consulted heavily on numerous occasions including voting on how our surplus is to be allocated at our AGM, through both large and small grants. Staff are routinely consulted and updated on changes affecting them directly. Members are regularly consulted on a wide range of topics via our eight elected staff and community representatives who sit on our Board. Partners organisations are regularly consulted via our Membership Board, with a number of organisations having non-voting places on the Board. Stakeholders are also involved in setting the objectives of the organisation for the coming year. Our funders are informed about performance against targets and have the opportunity through regular meetings to express their opinions.

What action, if any, has the company taken in response to feedback from its consultations? Following the membership vote at our AGM meetings over the last three years, priorities were identified as to how we should spend any surplus that was achieved. The winning schemes (all submissions came directly from the membership) involved creating accommodation for vulnerable people, developing a Dementia Café and enhancing our Older Peoples Inpatient Unit. We have now purchased two properties which have been converted into flats by our own employment scheme, Tukes with tenants having moved in in 2013/14, this really has transformed the lives of vulnerable service users. The Dementia Café opened on 5th June 2013 and is well used. Smaller grants have also been awarded to projects throughout the year.

Following a ballot regarding sickness, we have now implemented a new policy which has seen our sickness absence rates drop by some 40% since implementing on 1st October 2012
