NOTE TO THE FINANCIAL STATEMENTS

1. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES

At 1st April 2015, the directors loan account had a credit balance of £24,404. During the year the directors loaned £69,639 to the company. As a result, at the balance sheet date the Company owed the directors £94,043. The loan account was not overdrawn at any stage during the year.

The loan is interest free and repayable on demand.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2016.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 March 2016 in accordance with Section 476 of the Companies Act 2006.
