1. STATUTORY INFORMATION

Basis of preparing the financial statements

Turnover

Operating leases

Rentals under operating leases are charged to the profit and loss account on a straight line basis over the period of the lease.

Debtors

Short term debtors are measured at transaction price, less any impairment.

Creditors

Short term creditors are measured at the transaction price.
