



## INTERPRETATION

1 In these Articles -

- a "the Academies" means all the schools and educational institutions referred to in Article 4a and operated by the Academy Trust (and "Academy" shall mean any one of those schools or educational institutions),
- b "Academies Financial Handbook" means the document with that title published by the Education Funding Agency and amended from time to time, on behalf of the Secretary of State,
- c "Academy Financial Year" means the academic year from 1<sup>st</sup> of September to 31<sup>st</sup> of August of the following year,
- d "the Academy Trust" means the company intended to be regulated by these Articles and referred to in Article 2,
- e "Advisory Body" means a committee appointed by the Trustees pursuant to Articles 100-104 established either of representatives of one or more of the Academies or of advisors who will provide strategic support and capacity to advise the Trustees on the functioning of the Academies which may be established as or in addition to a Local Governing Body,
- f "the Articles" means these Articles of Association of the Academy Trust,
- g "Chief Executive Officer" means such person as may be appointed by the Trustees as the Chief Executive Officer of the Academy Trust,

- h “Chief Inspector” means Her Majesty’s Chief Inspector of Education, Children’s Services and Skills or his successor,
- i “clear days” in relation to the period of a notice means the period excluding the day when the notice is given or deemed to be given and the day on which it is given or on which it is to take effect,
- j “Clerk” means the clerk to the Trustees or any other person appointed to perform the duties of the clerk to the Trustees, including a joint, assistant or deputy clerk,
- k. “Executive Trustees” means such person or persons if appointed by the Trustees to be a Trustee to act on their behalf and with executive powers, including any Principal and/or Chief Executive Officer,
- l “financial expert” means an individual, company or firm who is authorised to give investment advice under the Financial Services and Markets Act 2000,
- m “Local Authority Associated Person” means any person associated (within the meaning given in section 69(5) of the Local Government and Housing Act 1989) with any local authority by which the Academy Trust is influenced,
- n “Local Governing Bodies” means the committees so called appointed pursuant to Articles 100-101A and 104 (and “Local Governing Body” means any one of these committees),
- o “Member” means a member of the Academy Trust and someone who as such is bound by the undertaking contained in Article 8,
- p “the Memorandum” means the Memorandum of Association of the Academy Trust,
- q “Office” means the registered office of the Academy Trust,
- r “Parent Local Governor” means the parent member of a Local Governing Body or Advisory Body established to represent the Academies elected or

- appointed in accordance with Articles 54-56, "Parent Trustees" means the Trustees if elected or appointed pursuant to Articles 53 – 56 inclusive,
- s "Principals" means the head teachers or heads of school of the Academies including any executive head teacher (and "Principal" means any one of these head teachers or heads of school),
- t "Principal Regulator" means the body or person appointed as the Principal Regulator under the Charities Act 2011,
- u "Relevant Funding Agreements" means the agreement or agreements entered into by the Academy Trust and the Secretary of State under section 1 of the Academies Act 2010 for the establishment of each Academy, including any variation or supplemental agreements thereof,
- v "the seal" means the common seal of the Academy Trust if it has one,
- w "Secretary of State" means the Secretary of State for Education or successor,
- x "Special Educational Needs" has the meaning set out in sections 20(1) and 21(2) of the Children and Families Act 2014,
- y "teacher" means a person employed under a contract of employment or a contract for services or otherwise engaged to provide his services as a teacher at one or more Academies,
- z "the Trustees" means the directors of the Academy Trust (and "Trustee" means any one of those directors), subject to the definition of this term at Article 6 9 (e) in relation to Articles 6 2-6 9,
- aa "the United Kingdom" means Great Britain and Northern Ireland,
- bb words importing the masculine gender only shall include the feminine gender Words importing the singular number shall include the plural number, and vice versa,
- cc subject as aforesaid, words or expressions contained in these Articles shall,

unless the context requires otherwise, bear the same meaning as in the Companies Act 2006, as appropriate,

- dd any reference to a statute or statutory provision shall include any statute or statutory provision which replaces or supersedes such statute or statutory provision including any modification or amendment thereto

2 The company's name is **GLF Schools** (and in this document it is called "**the Academy Trust**")

3 The Academy Trust's registered office is to be situated in England and Wales

### OBJECTS

4 The Academy Trust's objects ("**the Objects**") are specifically restricted to the following

- a to advance for the public benefit education in the United Kingdom, in particular but without prejudice to the generality of the foregoing, by establishing, maintaining, carrying on, managing and developing schools offering a broad and balanced curriculum ("**the mainstream Academies**") or educational institutions which are principally concerned with providing full-time or part-time education for children of compulsory school age who, by reason of illness, exclusion from school or otherwise, may not for any period receive suitable education unless alternative provision is made for them ("**the alternative provision Academies**") or 16 to 19 Academies offering a curriculum appropriate to the needs of its students ("**the 16 to 19 Academies**") or schools specially organised to make special educational provision for pupils with Special Educational Needs ("**the Special Academies**"),
- b to promote for the benefit of the inhabitants of the areas in which the Academies are situated the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or for the public at large in the interests

of social welfare and with the object of improving the condition of life of the said inhabitants

5 In furtherance of the Objects but not further or otherwise the Academy Trust may exercise the following powers

- a to draw, make, accept, endorse, discount, execute and issue promissory notes, bills, cheques and other instruments, and to operate bank accounts in the name of the Academy Trust,
- b to raise funds and to invite and receive contributions provided that in raising funds the Academy Trust shall not undertake any substantial permanent trading activities and shall conform to any relevant statutory regulations,
- c to acquire, alter, improve and (subject to such consents as may be required by law) to charge or otherwise dispose of property,
- d subject to Articles 6 6-6 8 below to employ such staff, as are necessary for the proper pursuit of the Objects and to make all reasonable and necessary provision for the payments of pensions and superannuation to staff and their dependants,
- e to establish or support, whether financially or otherwise, any charitable companies, trusts, associations or institutions formed for all or any of the Objects,
- f to co-operate with other charities, other independent and maintained schools, academies and institutions within the further education sector, voluntary bodies and statutory authorities operating in furtherance of the Objects and to exchange information and advice with them,
- g to pay out of funds of the Academy Trust the costs, charges and expenses of and incidental to the formation and registration of the Academy Trust,
- h to establish, maintain, carry on, manage and develop the [Academies at locations to be determined by the Trustees and in so doing shall have regard to the respective ethos and mission statement of each Academy,

- i to offer scholarships, exhibitions, prizes and awards to pupils and students former pupils and former students, and otherwise to encourage and assist pupils and students and former pupils and former students,
- j to provide educational facilities and services to students of all ages and the wider community for the public benefit;
- k to carry out research into the development and application of new techniques in education and to their approach to curriculum development and delivery and to publish the results of such research, and to develop means of benefiting from application of the experience of industry, commerce, other schools, educational institutions and the voluntary sector to the education of pupils and students in academies,
- l subject to such consents as may be required by law and/or by any contract entered into by or on behalf of the Academy Trust, to borrow and raise money for the furtherance of the Objects in such manner and on such security as the Academy Trust may think fit,
- m to deposit or invest any funds of the Academy Trust not immediately required for the furtherance of its Objects (but to invest only after obtaining such advice from a financial expert as the Trustees consider necessary and having regard to the suitability of investments and the need for diversification),
- n to delegate the management of investments to a financial expert, but only on terms that:
  - i the investment policy is set down in writing for the financial expert by the Trustees,
  - ii every transaction is reported promptly to the Trustees,
  - iii the performance of the investments is reviewed regularly with the Trustees,
  - iv the Trustees are entitled to cancel the delegation arrangement at any

- v the investment policy and the delegation arrangement are reviewed at least once a year,
- vi all payments due to the financial expert are on a scale or at a level which is agreed in advance and are notified promptly to the Trustees on receipt, and
- vii the financial expert must not do anything outside the powers of the Trustees,
- p to arrange for investments or other property of the Academy Trust to be held in the name of a nominee company acting under the control of the Trustees or of a financial expert acting under their instructions, and to pay any reasonable fee required,
- q to provide indemnity arrangements to Trustees and members of any Local Governing Body (in so far as necessary) in accordance with, and subject to the conditions of section 232 to 235 of the Companies Act 2006, section 189 of the Charities Act 2011 or any other provision of law applicable to charitable companies and any such indemnity is limited accordingly,
- r not used,
- s to establish subsidiary companies to carry on any trade or business for the purpose of raising funds for the Academy Trust, and
- t to do all such other lawful things as are necessary for or are incidental to or conducive to the achievement of the Objects

6 1 The income and property of the Academy Trust shall be applied solely towards the promotion of the Objects

6 2 None of the income or property of the Academy Trust may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way of profit to any Member of the Academy Trust Nonetheless a Member of the Academy Trust may

- a benefit as a beneficiary of the Academy Trust,
- b be paid reasonable and proper remuneration for any goods or services supplied to the Academy Trust,
- c be paid rent for premises let by the Member of the Academy Trust if the amount of the rent and other terms of the letting are reasonable and proper, and
- d be paid interest on money lent to the Academy Trust at a reasonable and proper rate, such rate not to exceed 2 per cent per annum below the base lending rate of a UK clearing bank selected by the Trustees, or 0.5%, whichever is the higher,

provided that in each case such benefit or payment does not contravene the provisions of the Academies Financial Handbook

6.2A The Members may only rely upon the authority provided by Article 6.2 if each of the following conditions is satisfied

- a the remuneration or other sums paid to the Member do not exceed an amount that is reasonable in all the circumstances;
- b that Member is absent from the part of any meeting at which there is discussion of
  - i his or her remuneration, or any matter concerning the contract, payment or benefit, or
  - ii his or her performance of the contract, or
  - iii any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under Article 6.2, or
  - iv any other matter relating to a payment or the conferring of any benefit permitted by Article 6.2,
- c that Member does not vote on any such matter and is not to be counted

when calculating whether a quorum of Trustees is present at the meeting,

- d the Trustees are satisfied that it is in the interests of the Academy Trust to contract with that Member rather than with someone who is not a Member  
In reaching that decision the Trustees must balance the advantage of contracting with a Member against the disadvantages of doing so (especially the loss of the Member's services as a result of dealing with the Member's conflict of interest), and
- e the reason for their decision is recorded by the Trustees in the minute book

6.3 A Trustee and any member of any Local Governing Body (in so far as necessary) may benefit from any indemnity arrangement purchased at the Academy Trust's expense or any arrangement so agreed with the Secretary of State or as required by the Academies Financial Handbook to cover the liability of the Trustees and members of any Local Governing Body which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust provided that any such arrangement shall not extend to (i) any claim arising from any act or omission which the Trustees or the Local Governing Body (or any of them as appropriate) knew to be a breach of trust or breach of duty or which was committed by the Trustees or the members of the Local Governing Body (or any of them as appropriate) in reckless disregard to whether it was a breach of trust or breach of duty or not, and (ii) the costs of any unsuccessful defence to a criminal prosecution brought against the Trustees or the Local Governing Body (or any of them as appropriate) in their capacity as directors or trustees of the Academy Trust. Further, this Article does not authorise a Trustee or Member of a Local Governing Body (if appropriate) to benefit from any indemnity arrangement that would be rendered void by any provision of the Companies Act 2006, the Charities Act 2011 or any other provision of law.

6.4 A company, which has shares listed on a recognised stock exchange and of which any one Trustee holds no more than 1% of the issued capital of that company, may receive fees, remuneration or other benefit in money or money's worth from the Academy Trust.

6 5 A Trustee may at the discretion of the Trustees be reimbursed from the property of the Academy Trust for reasonable expenses properly incurred by him or her when acting on behalf of the Academy Trust, but excluding expenses in connection with foreign travel

6 6 No Trustee may

- a buy any goods or services from the Academy Trust,
- b sell goods, services, or any interest in land to the Academy Trust,
- c be employed by, or receive any remuneration from the Academy Trust (other than an Executive Trustee to the extent he or she is a Trustee, whose employment and/or remuneration is subject to the procedure and conditions in Article 6 8), or
- d receive any other financial benefit from the Academy Trust,
- e unless
  - i the payment is permitted by Article 6 7 and the Trustees follow the procedure and observe the conditions set out in Article 6 8, and
  - ii the Trustees obtain the prior written approval of the Charity Commission and fully comply with any procedures it prescribes

6 7 Subject to Article 6 8, a Trustee may

- a receive a benefit from the Academy Trust in the capacity of a beneficiary of the Academy Trust,
- b be employed by the Academy Trust or enter into a contract for the supply of goods or services to the Academy Trust, other than for acting as a Trustee,
- c receive interest on money lent to the Academy Trust at a reasonable and proper rate not exceeding 2% per annum below the base rate of a clearing bank to be selected by the Trustees, or 0 5%, whichever is the higher; and
- d receive rent for premises let by the Trustee to the Academy Trust if the amount of the rent and the other terms of the lease are reasonable and

provided that in each case such benefit or payment does not contravene the provisions of the Academies Financial Handbook

6.8 The Academy Trust and its Trustees may only rely upon the authority provided by Article 6.7 if each of the following conditions is satisfied

- a the remuneration or other sums paid to the Trustee do not exceed an amount that is reasonable in all the circumstances,
- b the Trustee is absent from the part of any meeting at which there is discussion of
  - i his or her employment, remuneration, or any matter concerning the contract, payment or benefit, or
  - ii his or her performance in the employment, or his or her performance of the contract (unless present solely in his or her capacity as an employee), or
  - iii any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under Article 6.7, or
  - iv any other matter relating to a payment or the conferring of any benefit permitted by Article 6.7,
- c the Trustee does not vote on any such matter and is not to be counted when calculating whether a quorum of Trustees is present at the meeting,
- d save in relation to employing or contracting with an Executive Trustee, the other Trustees are satisfied that it is in the interests of the Academy Trust to employ or to contract with that Trustee rather than with someone who is not a Trustee. In reaching that decision the Trustees must balance the advantage of employing a Trustee against the disadvantages of doing so (especially the loss of the Trustee's services as a result of dealing with the Trustee's conflict of interest),

6 8A The provision in Article 6 6 (c) that no Trustee may be employed by or receive any remuneration from the Academy Trust (other than an Executive Trustee) does not apply to an employee of the Academy Trust who is subsequently elected or appointed as a Trustee save that this Article shall only allow such a Trustee to receive remuneration or benefit from the Academy Trust in his capacity as an employee of the Academy Trust and provided that the procedure as set out in Articles 6 8(b) and 6 8 (c) is followed

6 9 In Articles 6 2-6 9

- a "company" shall include any company in which the Academy Trust
- b holds more than 50% of the shares, or
- c controls more than 50% of the voting rights attached to the shares, or
- d has the right to appoint one or more directors to the board of the company,
- e "Trustee" shall include any child, stepchild, parent, grandchild, grandparent, brother, sister or spouse of the Trustee or any person living with the Trustee as his or her partner,
- f the employment or remuneration of a Trustee includes the engagement or remuneration of any firm or company in which the Trustee is
  - i a partner,
  - ii an employee,
  - iii a consultant,
  - iv a director,
  - v a member, or

7 The liability of the Members of the Academy Trust is limited

8 Every Member of the Academy Trust undertakes to contribute such amount as may be required (not exceeding £10) to the Academy Trust's assets if it should be wound up while he or she is a Member or within one year after he or she ceases to be a Member, for payment of the Academy Trust's debts and liabilities before he or she ceases to be a Member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributors among themselves

9 If the Academy Trust is wound up or dissolved and after all its debts and liabilities (including any under section 2 of the Academies Act 2010) have been satisfied there remains any property it shall not be paid to or distributed among the Members of the Academy Trust (except to a Member that is itself a charity), but shall be given or transferred to some other charity or charities having objects similar to the Objects which prohibits the distribution of its or their income and property to an extent at least as great as is imposed on the Academy Trust by Article 6 above, chosen by the Members of the Academy Trust at or before the time of dissolution and if that cannot be done then to some other charitable object

86 Where the chairman is absent from any meeting or there is at the time a vacancy in the office of the chairman, the vice-chairman shall act as the chair for the purposes of the meeting

87-89 Not used

90 The Trustees may remove the chairman or vice-chairman from office in accordance with these Articles

91 A resolution to remove the chairman or vice-chairman from office which is passed at a meeting of the Trustees shall not have effect unless

- a it is confirmed by a resolution passed at a second meeting of the Trustees held not less than fourteen days after the first meeting, and
- b the matter of the chairman's or vice-chairman's removal from office is specified as an item of business on the agenda for each of those meetings

92 Before the Trustees resolve at the relevant meeting on whether to confirm the resolution to remove the chairman or vice-chairman from office, the Trustee or Trustees proposing his removal shall at that meeting state their reasons for doing so and the chairman or vice-chairman shall be given an opportunity to make a statement in response

### POWERS OF TRUSTEES

93 Subject to provisions of the Companies Act 2006, the Articles and to any directions given by special resolution, the business of the Academy Trust shall be managed by the Trustees who may exercise all the powers of the Academy Trust. No alteration of the Articles and no such direction shall invalidate any prior act of the Trustees which would have been valid if that alteration had not been made or that direction had not been given. The powers given by this Article shall not be limited by any special power given to the Trustees by the Articles and a meeting of Trustees at which a quorum is present may exercise all the powers exercisable by the Trustees.

94 In addition to all powers hereby expressly conferred upon them and without detracting from the generality of their powers under the Articles the Trustees shall have the following powers, namely

- a to expend the funds of the Academy Trust in such manner as they shall consider most beneficial for the achievement of the Objects and to invest in the name of the Academy Trust such part of the funds as they may see fit and to direct the sale or transposition of any such investments and to expend the proceeds of any such sale in furtherance of the Objects; and
- b to enter into contracts on behalf of the Academy Trust

95 In the exercise of their powers and functions, the Trustees may consider any advice given by the Chief Executive Officer and the Principals to the extent he or she is not a Trustee and any other executive officer.

96 Any bank account in which any money of the Academy Trust is deposited shall be operated by the Trustees in the name of the Academy Trust. All cheques BACS and orders for the payment of money from such an account shall be signed or authorised by at least two signatories authorised by the Trustees.

### CONFLICTS OF INTEREST

97. Any Trustee who has or can have any direct or indirect duty or personal interest (including but not limited to any Personal Financial Interest) which conflicts or may conflict with his duties as a Trustee shall disclose that fact to the Trustees as soon as he

becomes aware of it A Trustee must absent himself from any discussions of the Trustees in which it is possible that a conflict will arise between his duty to act solely in the interests of the Academy Trust and any duty or personal interest (including but not limited to any Personal Financial Interest)

98 For the purpose of Article 97, a Trustee has a **Personal Financial Interest** in the employment or remuneration of, or the provision of any other benefit to, that Trustee as permitted by and as defined by Articles 6 5-6 8A

### THE MINUTES

99 The minutes of the proceedings of a meeting of the Trustees shall be drawn up and entered into a book kept for the purpose by the person acting as Clerk for the purposes of the meeting, and shall be signed (subject to the approval of the Trustees) at the same or next subsequent meeting by the person acting as chairman thereof

### COMMITTEES

100 Subject to these Articles, the Trustees

- a) may appoint committees to be known as Local Governing Bodies or Advisory Bodies for each Academy (and the same Local Governing Body or Advisory Body may be appointed for more than one Academy); and
- b) may establish any other committee.

101 Subject to these Articles, the constitution, membership and proceedings of any committee shall be determined by the Trustees The establishment, terms of reference, constitution and membership of any committee of the Trustees shall be reviewed at least once in every twelve months The membership of any committee of the Trustees may include persons who are not Trustees, provided that (with the exception of the Local Governing Bodies) a majority of members of any such committee shall be Trustees Except in the case of a Local Governing Body, no vote on any matter shall be taken at a meeting of a committee of the Trustees unless the majority of members of the committee present are Trustees

101A The Trustees shall ensure that any Local Governing Body shall include at least 2

### DELEGATION

105 The Trustees may delegate any of their powers or functions (including the power to sub-delegate) to any Trustee, committee (including any Local Governing Body), the Chief Executive Officer any Principal or any other holder of an executive office Any such delegation shall be made in writing and subject to any conditions the Trustees may impose, and may be revoked or altered

105A A Trustee, committee (including any Local Governing Body), the Chief Executive Officer or Principal or any other holder of an executive office to whom a power or function of the Trustees is delegated under Article 105 may further sub-delegate those powers or functions (or any of them) to a further person Where any power or function of the Trustees is sub-delegated by any person to whom it has been delegated, that person must inform the Trustees as soon as reasonably practicable which powers and functions have been further delegated and to whom, and any such sub-delegation shall be made subject to any conditions the Trustees may impose, and may be revoked or altered

106 Where any power or function of the Trustees has been exercised by any committee (including any Local Governing Body), any Trustee, the Chief Executive Officer or any Principal any other holder of an executive office, or a person to whom a power or function has been sub-delegated under Article 105A, that person or committee shall report to the Trustees in respect of any action taken or decision made with respect to the exercise of that power or function at the meeting of the Trustees

The Trustees may delegate such powers and functions as they consider are required by the Chief Executive Officer and the Principals for the internal organisation, management and control of the Academies (including the implementation of all policies approved by the Trustees and for the direction of the teaching and curriculum at the Academies)

### MEETINGS OF THE TRUSTEES

108 Subject to these Articles, the Trustees may regulate their proceedings as they think fit

109 The Trustees shall hold at least three meetings in every school year. Meetings of the Trustees shall be convened by the Clerk. In exercising his functions under this Article the Clerk shall comply with any direction

- b given by the chairman of the Trustees or, in his absence or where there is a vacancy in the office of chairman, the vice-chairman of the Trustees, so far as such direction is not inconsistent with any direction given as mentioned in (a)

110 Any three Trustees may, by notice in writing given to the Clerk, requisition a meeting of the Trustees, and it shall be the duty of the Clerk to convene such a meeting as soon as is reasonably practicable

111 Each Trustee shall be given at least seven clear days before the date of a meeting

113 A resolution to rescind or vary a resolution carried at a previous meeting of the Trustees shall not be proposed at a meeting of the Trustees unless the consideration of the rescission or variation of the previous resolution is a specific item of business on the agenda for that meeting

114 A meeting of the Trustees shall be terminated forthwith if

- a the Trustees so resolve, or
- b the number of Trustees present ceases to constitute a quorum for a meeting of the Trustees in accordance with Article 117, subject to Article 119

115 Where in accordance with Article 114 a meeting is not held or is terminated before all the matters specified as items of business on the agenda for the meeting have been disposed of, a further meeting shall be convened by the Clerk as soon as is reasonably practicable, but in any event within seven days of the date on which the meeting was originally to be held or was so terminated

119 The quorum for the purposes of

- a any vote on the removal of a Trustee in accordance with Article 66, and

123 A resolution in writing, signed by all the Trustees entitled to receive notice of a meeting of Trustees or of a committee of Trustees, shall be valid and effective as if it had been passed at a meeting of Trustees or (as the case may be) a committee of Trustees duly convened and held Such a resolution may consist of several documents in the same form, each signed by one or more of the Trustees

124 Subject to Article 125, the Trustees shall ensure that a copy of

125 There may be excluded from any item required to be made available in pursuance of Article 124, any material relating to

- b a named pupil or named student at, or candidate for admission or referral to, any Academy, and
- c any matter which, by reason of its nature, the Trustees are satisfied should remain confidential

126 Any Trustee shall be able to participate in meetings of the Trustees by telephone or video conference provided that

- a he has given notice of his intention to do so detailing the telephone number on which he can be reached and/or appropriate details of the video conference suite from which he shall be taking part at the time of the meeting at least 48 hours before the meeting, and
- b the Trustees have access to the appropriate equipment if after all reasonable efforts it does not prove possible for the person to participate by telephone or video conference the meeting may still proceed with its business provided it is otherwise quorate

127 The Trustees may from time to time appoint any person whether or not a Member of the Academy Trust to be a patron of the Academy Trust or to hold any honorary office and may determine for what period he is to hold such office

### THE SEAL

128 The seal, if any, shall only be used by the authority of the Trustees or of a committee of Trustees authorised by the Trustees. The Trustees may determine who shall sign any instrument to which the seal is affixed and unless otherwise so determined it shall be signed by a Trustee and by the Clerk or by a second Trustee.

### ACCOUNTS

129 Accounts shall be prepared in accordance with the relevant statement of recommended practice published by the Charity Commission from time to time (the “**Statement of Recommended Practice**”) as if the Academy Trust was a non-exempt charity and Parts 15 and 16 of the Companies Act 2006 and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

### ANNUAL REPORT

130 The Trustees shall prepare its Annual Report in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

### ANNUAL RETURN

131 The Trustees shall comply with their obligations under Part 24 of the Companies Act 2006 (or any statutory re-enactment or modification of that Act) with regard to the preparation of an annual return to the Registrar of Companies and in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and to the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

### NOTICES

132 Any notice to be given to or by any person pursuant to the Articles (other than a notice calling a meeting of the Trustees) shall be in writing or shall be given using electronic communications to an address for the time being notified for that purpose to the person giving the notice. In these Articles, "Address" in relation to electronic communications, includes a number or address used for the purposes of such communications.

133 A notice may be given by the Academy Trust to a Member either personally or by sending it by post in a prepaid envelope addressed to the Member at his registered address or by leaving it at that address or by giving it using electronic communications to an address for the time being notified to the Academy Trust by the Member. A Member whose registered address is not within the United Kingdom and who gives to the Academy Trust an address within the United Kingdom at which notices may be given to him, or an address to which notices may be sent using electronic communications, shall be entitled to have notices given to him at that address, but otherwise no such Member shall be entitled to receive any notice from the Academy Trust.

134 A Member present, either in person or by proxy, at any meeting of the Academy Trust shall be deemed to have received notice of the meeting and, where necessary, of the purposes for which it was called.

135 Proof that an envelope containing a notice was properly addressed, prepaid and posted shall be conclusive evidence that the notice was given. Proof that a notice contained in an electronic communication was sent in accordance with guidance issued by the Institute of Chartered Secretaries and Administrators shall be conclusive evidence that the notice was given. A notice shall be deemed to be given at the expiration of 48 hours after the envelope containing it was posted or, in the case of a notice contained in an electronic communication, at the expiration of 48 hours after the time it was sent.

### **INDEMNITY**

136 Subject to the provisions of the Companies Act 2006 and Article 6.3 every Trustee and every member of any Local Governing Body and/or Advisory Body (in so far as necessary) or other officer or auditor of the Academy Trust shall be indemnified out of the assets of the Academy Trust against any liability incurred by him in that capacity in

### **RULES**

137 The Trustees may from time to time make such rules or bye laws as they may deem necessary or expedient or convenient for the proper conduct and management of the Academy Trust and for purposes of prescribing classes of and conditions of membership, and in particular but without prejudice to the generality of the foregoing, they may by such rules or bye laws regulate

- a the admission and classification of Members of the Academy Trust (including the admission of organisations to membership) and the rights and privileges of such Members, and the conditions of membership and the terms on which Members may resign or have their membership terminated and the entrance fees, subscriptions and other fees or payments to be made by Members,
- b the conduct of Members of the Academy Trust in relation to one another, and to the Academy Trust's servants,
- c the setting aside of the whole or any part or parts of the Academy Trust's premises at any particular time or times or for any particular purpose or purposes,
- d the procedure at General Meetings and meetings of the Trustees and committees of the Trustees and meetings of the Local Governing Bodies in so far as such procedure is not regulated by the Articles, and
- e generally, all such matters as are commonly the subject matter of company rules

138 The Academy Trust in general meeting shall have power to alter, add or to repeal the rules or bye laws and the Trustees shall adopt such means as they think sufficient to bring to the notice of Members of the Academy Trust all such rules or bye laws, which

### **AVOIDING INFLUENCED COMPANY STATUS**

139 Notwithstanding the number of Members from time to time, the maximum aggregate number of votes exercisable by Local Authority Associated Persons shall never exceed 19.9% of the total number of votes exercisable by Members in general meeting and the votes of the other Members having a right to vote at the meeting will be increased on a pro-rata basis

140 No person who is a Local Authority Associated Person may be appointed or elected as a Trustee if, once the appointment or election had taken effect, the number of Trustees who are Local Authority Associated Persons would represent 20% or more of the total number of Trustees Upon any resolution put to the Trustees, the maximum aggregate number of votes exercisable by any Trustees who are Local Authority Associated Persons shall represent a maximum of 19.9% of the total number of votes cast by the Trustees on such a resolution and the votes of the other Trustees having a right to vote at the meeting will be increased on a pro-rata basis

141 No person who is a Local Authority Associated Person is eligible to be appointed or elected to the office of Trustee unless his appointment or election to such office is authorised by the local authority to which he is associated

142 If at the time of either his becoming a Member of the Academy Trust or his first appointment or election to office as a Trustee any Member or Trustee was not a Local Authority Associated Person but later becomes so during his membership or tenure as a Trustee he shall be deemed to have immediately resigned his membership and/or resigned from his office as a Trustee as the case may be

143 If at any time the number of Trustees or Members who are also Local Authority Associated Persons would (but for Articles 139 to 142 inclusive) represent 20% or more of the total number of Trustees or Members (as the case may be) then a sufficient number of the Trustees or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned as Trustees or Members (as the case may be) immediately before the occurrence of such an event to ensure that at all

144 The Members will each notify the Academy Trust and each other if at any time they believe that the Academy Trust or any of its subsidiaries has become subject to the influence of a local authority (as described in section 69 of the Local Government and Housing Act) 1989
