THIS THIRD SUPPLEMENTAL SECURITY AGREEMENT is made by way of deed on
28 April 2020

BY:

- (1) **THE PERSONS** listed in Schedule 1 (*Chargors*) (each, a "**Chargor**"), in favour of:
- (2) **U.S. BANK TRUSTEES LIMITED** as trustee for each of the Secured Parties on the terms and conditions set out in the Intercreditor Agreement (the "**Security Agent**").

RECITALS:

- (A) The Lenders made multicurrency revolving credit facilities available to the Borrowers pursuant to the Facilities Agreement (as defined below).
- (B) Pursuant to the Original Security Agreement, the First Supplemental Security Agreement and the Second Supplemental Security Agreement (each, as defined below), the Chargors created security over certain of their assets in favour of the Security Agent as continuing security for the payment and discharge of all the Secured Obligations (as defined in the Original Security Agreement, the First Supplemental Security Agreement and the Second Supplemental Security Agreement).
- (C) The Lenders have agreed to amend the Facilities Agreement as set out in the Amendment Agreement (each, as defined below).
- (D) The Chargors wish to confirm the existing security created pursuant to the Original Security Agreement, the First Supplemental Security Agreement and the Second Supplemental Security Agreement and grant security over the Charged Assets in respect of its obligations to the Lenders as amended by the Amendment Agreement.
- (E) This Third Supplemental Security Agreement is supplemental to the Original Security Agreement, the First Supplemental Security Agreement and the Second Supplemental Security Agreement.

IT IS AGREED as follows:

1. DEFINITIONS AND INTERPRETATION

1.1 Definitions

In this Third Supplemental Security Agreement:

"Amended Facilities Agreement" means the Facilities Agreement, as amended by the Amendment Agreement.

"Amended Secured Obligations" means all present and future monies, debts, liabilities and obligations at any time due, owing or incurred by any member of the Group to any Secured Party (both actual and contingent and whether incurred solely or jointly and as principal or surety or with any other person or in any other capacity including without limitation any amounts (such as post-insolvency interest) that would be included in any thereof but for any discharge, non-provability, unenforceability or non-allowance of those amounts in any insolvency or other proceedings) under:

- (a) the RCF Finance Documents;
- (b) the Hedging Agreements;
- (c) the Senior Secured Notes Documents;
- (d) the Pari Passu Debt Documents;
- (e) the Credit Facility Documents other than the RCF Finance Documents; and
- (f) any Additional Liabilities in respect of any Secured Debt Documents,

and including, for the avoidance of doubt, such obligations arising under the Secured Debt Documents on and after the date of this Third Supplemental Security Agreement.

"Amendment Agreement" means the amendment agreement dated 5 April 2020 between Mabel Mezzco Limited as the parent, Santander UK plc as agent and the financial institutions named therein as Obligors.

"Assigned Agreements" means each Secured Notes Proceeds Loan, the contracts listed as Assigned Agreements in Schedule 4 (*Assigned Agreements (Contracts)*) or listed as Assigned Agreements in any Security Accession Deed, the Intra-Group Loans and any other agreement designated as an Assigned Agreement by the relevant Chargor (or the Obligors' Agent on its behalf) and the Security Agent.

"Cash Collateral Accounts" means the accounts (if any) listed in Part A of Schedule 3 (*Cash Collateral Accounts (Blocked)*) or listed as Cash Collateral Accounts in any Security Accession Deed, and any other Bank Account which is designated as a Cash Collateral Account by the relevant Chargor (or the Obligors' Agent on its behalf) and the Security Agent, and any replacement account or any sub-division or sub-account of those accounts.

"Collection Accounts" means the accounts (if any) listed in Part B of Schedule 3 (*Collection Accounts (Not Blocked)*) or listed as Collection Accounts in any Security Accession Deed, or which is designated as a Collection Account by the relevant Chargor (or the Obligors' Agent on its behalf) and the Security Agent, and any replacement account or any sub-division or sub-account of those accounts.

"Equipment" means all plant, machinery, vehicles, computers, office and other equipment including that equipment (if any) listed in Schedule 6 (*Equipment*) or in any Security Accession Deed.

"Facilities Agreement" means the super senior revolving facilities agreement dated 28 January 2015 (as amended by an amendment letter dated 11 November 2016, as amended and restated by an amendment and restatement agreement dated 23 June 2017 and as amended by an amendment letter dated 21 December 2018) between, among others, Mabel Mezzco Limited as the parent, Abbey National Treasury Services plc as arranger, Santander UK plc as agent, U.S. Bank Trustees Limited as security agent and the financial institutions named therein as Lenders.

"First Supplemental Security Agreement" means the English law governed supplemental security agreement relating to the Original Security Agreement dated 10 July 2017 granted by the Chargors in favour of the Security Agent.

"Fixed Security" means any mortgage, fixed charge or assignment expressed to be created by or pursuant to Clause 4 (*Supplemental Fixed Security*).

"Insurances" means the benefits arising from all policies of insurance (including all rights of recovery and all proceeds of them) either now or in the future held by, or written in favour of, a Chargor or in which it is otherwise interested, including those policies (if any) listed in Schedule 7 (*Insurance Policies*) or in any Security Accession Deed but excluding any third party liability or public liability insurance and any directors' and officers' insurance.

"Intellectual Property" means any patents, trademarks, service marks, designs, business names, copyrights, database rights, design rights, domain names, moral rights, inventions, confidential information, knowhow and other intellectual property rights and interests, whether registered or unregistered, the benefit of all applications and rights to use such assets including the intellectual property rights (if any) listed in Schedule 5 (*Intellectual Property*) or in any Security Accession Deed.

"Intercreditor Agreement" means the intercreditor agreement dated 28 January 2015 between, among others, Mabel Mezzco Limited as the parent, Wagamama Finance plc as original issuer, the Chargors together with Wagamama USA Holding Inc. and Wagamama Inc. as original debtors, Abbey National Treasury Services plc as arranger, Santander UK plc as RCF agent and the Security Agent as security agent and senior secured notes trustee.

"Majority Lenders" has the meaning given to that term in the Amended Facilities Agreement.

"Material Property" means any Property which (i) is a freehold Property and has a market value of £2,000,000 or above or (ii) is a leasehold Property where the relevant lease has an unexpired term of ten (10) years or more or includes an option to purchase the freehold of the relevant Property.

"Original Security" means the Security created by or pursuant to the Original Security Agreement, the First Supplemental Security Agreement and the Second Supplemental Security Agreement.

"Original Security Agreement" means the English law governed debenture dated 28 January 2015 granted by the Chargors in favour of the Security Agent.

"Property" means all freehold, heritable, leasehold or commonhold property and the buildings and fixtures (including trade fixtures) on that property from time to time including the property (if any) listed in Schedule 2 (*Property*) and in any Security Accession Deed.

"Second Supplemental Security Agreement" means the English law governed supplemental security agreement relating to the Original Security Agreement and the

First Supplemental Security Agreement dated 22 January 2019 granted by the Chargors in favour of the Security Agent.

1.2 Importation of terms

Unless defined in this Third Supplemental Security Agreement, or the context otherwise requires, a term defined in the Original Security Agreement or the Intercreditor Agreement has the same meaning in this Third Supplemental Security Agreement, or any notice given under or in connection with this Third Supplemental Security Agreement.

1.3 Construction

In this Third Supplemental Security Agreement the rules of interpretation contained in clause 1.2 (*Construction*) of the Original Security Agreement shall apply to the construction of this Third Supplemental Security Agreement, or in any notice given under or in connection with this Third Supplemental Security Agreement.

1.4 Inconsistency between the Intercreditor Agreement, the Original Security Agreement and this Third Supplemental Security Agreement

- (a) Notwithstanding any other provision of this Third Supplemental Security Agreement:
 - (i) the terms, rights, obligations and Security created pursuant to this Third Supplemental Security Agreement shall at all times be subject to the terms and Security created by the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) until such time as the Security created by or pursuant to the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) has no, or ceases to have, effect and provided no default or event of default (howsoever defined) under the Secured Debt Documents shall result solely from the execution of this Third Supplemental Security Agreement or from the existence of this Third Supplemental Security Agreement as the same time as the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement), and such terms of this Third Supplemental Security Agreement shall be construed accordingly; and
 - (ii) where a right or asset has been assigned by a Chargor (subject to a proviso for re-assignment on redemption) under the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) and that Chargor purports to assign the same asset or right under this Third Supplemental Security Agreement, that second assignment will instead take effect as a fixed charge over the Chargor's equitable right of redemption under the first assignment and will only take effect as an assignment if the relevant Security created by the Original Security Agreement (as supplemented by the First Supplemental Security

Agreement and the Second Supplemental Security Agreement) has no, or ceases to have, effect at a time when this Third Supplemental Security Agreement still has effect and, in circumstances where the Security constituted by the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) remains in force, any reference in this Third Supplemental Security Agreement to an asset secured under the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) being assigned under the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) being first ranking or secured with full title guarantee, shall be construed accordingly.

- (b) If the Chargor is in compliance with the terms of the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) (including without limitation, any obligation to deliver or deposit any notices, deeds, documents or title, certificates, evidence of ownership or related documentation) then, to the extent that the terms of this Third Supplemental Security Agreement are the same and apply in respect of the same assets, the Chargor will be deemed to have complied with the respective terms of this Third Supplemental Security Agreement.
- (c) Notwithstanding anything herein to the contrary, the Security granted pursuant to this Third Supplemental Security Agreement and the exercise of any right or remedy by the Security Agent and the other Secured Parties are subject to the provisions of the Intercreditor Agreement. In the event of any conflict or inconsistency between the express provisions of the Intercreditor Agreement and this Third Supplemental Security Agreement, the provisions of the Intercreditor Agreement shall prevail.

1.5 Present and future assets

- (a) A reference in this Third Supplemental Security Agreement to any Material Property, Charged Property or other asset includes, unless the contrary intention appears, present and future Material Property, Charged Property and other assets.
- (b) The absence of or incomplete details of any Charged Property in any Schedule shall not affect the validity or enforceability of any Security under this Third Supplemental Security Agreement.

1.6 Real Property

- (a) A reference in this Third Supplemental Security Agreement to any freehold, leasehold or commonhold property includes all buildings, fixtures and fittings from time to time on or forming part of that property and all Related Rights.
- (b) The terms of the Amended Facilities Agreement and each other Secured Debt Document are incorporated into this Third Supplemental Security Agreement

and each other Secured Debt Document to the extent required for any purported disposition of any Real Property contained in any Secured Debt Document to be a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989.

1.7 Separate Security

Clauses 4.1 (*Fixed Charges*) and 4.2 (*Security Assignment*) shall be construed as creating a separate and distinct mortgage, fixed charge or assignment over each relevant asset within any particular class of assets defined in this Third Supplemental Security Agreement and the failure to create an effective mortgage, fixed charge or assignment (whether arising out of this Third Supplemental Security Agreement or any act or omission by any party) over any one asset shall not affect the nature or validity of the mortgage, charge or assignment imposed on any other asset whether within that same class of assets or not.

1.8 Security Agent assumes no obligation

- (a) The Security Agent shall not be under any obligation in relation to the Charged Assets as a consequence of this Third Supplemental Security Agreement and the Chargors shall at all times remain liable to perform all obligations in respect of the Charged Assets.
- (b) The Security Agent shall not be responsible for the perfection of Security constituted by this Third Supplemental Security Agreement and shall not be liable for any failure to perfect Security.

2. CONFIRMATION OF EXISTING SECURITY

For the avoidance of doubt, each Chargor confirms for the benefit of the Secured Parties that with effect from the date of this Third Supplemental Security Agreement, the Original Security shall:

- (a) remain in full force and effect notwithstanding the amendments referred to in clause 2.1 (*The Facilities Agreement*) of the Amendment Agreement; and
- (b) continue to secure its Amended Secured Obligations under the Secured Debt Documents (including, but not limited to, under the Amended Facilities Agreement).

3. COMMON PROVISIONS

3.1 Common provisions as to all Security

All the Security created by or pursuant to this Third Supplemental Security Agreement is:

- (a) created with full title guarantee;
- (b) created in favour of the Security Agent as trustee for the Secured Parties and the Security Agent shall hold the benefit of this Third Supplemental Security

Agreement and the Security created by or pursuant to it on trust for the Secured Parties; and

- (c) continuing security for the payment and discharge of all the Amended Secured Obligations.

3.2 Supplemental Security

All the Security created by or pursuant to Clauses 4 (*Supplemental Fixed Security*) and 5 (*Supplemental Floating Charge*) is created in addition and without prejudice to the security confirmation contained in Clause 2 (*Confirmation of Existing Security*) and without prejudice but subject only to the Original Security.

3.3 Consent for Fixed Security

The Chargors create each Fixed Security subject to obtaining any necessary consent to such Fixed Security from any relevant third party.

4. SUPPLEMENTAL FIXED SECURITY

4.1 Fixed Charges

Each Chargor charges all of its right, title and interest in the following assets from time to time owned by it or in which it has an interest and, in each case, all Related Rights:

- (a) by way of legal mortgage, all Material Property; and
- (b) by way of fixed charge:
 - (i) all other interests (not effectively charged under paragraph (a) above) in any Material Property;
 - (ii) all Subsidiary Shares;
 - (iii) all Investments (other than Subsidiary Shares);
 - (iv) all Equipment;
 - (v) all Book Debts;
 - (vi) all Cash Collateral Accounts;
 - (vii) all Material Intellectual Property;
 - (viii) its goodwill and uncalled capital; and
 - (ix) to the extent not effectively assigned by Clause 4.2 (*Security Assignment*):
 - (A) the Assigned Agreements;
 - (B) the Insurances; and

(C) the Hedging Agreements.

4.2 Security Assignment

Each Chargor assigns absolutely all its right, title and interest in the following assets and, in each case, all Related Rights:

- (a) the Assigned Agreements;
- (b) the Insurances; and
- (c) the Hedging Agreements,

provided that on payment or discharge in full of the Amended Secured Obligations the Security Agent will at the request and cost of the relevant Chargor and as soon as reasonably practicable re-assign the relevant rights, title and interest in the assigned assets to that Chargor (or as it shall direct).

5. SUPPLEMENTAL FLOATING CHARGE

5.1 Floating Charge

- (a) Each Chargor charges by way of floating charge in favour of the Security Agent all its present and future assets not effectively charged by way of fixed charge under Clause 4.1 (*Fixed Charges*) or assigned under Clause 4.2 (*Security Assignment*) and, in each case, all Related Rights.
- (b) The floating charge created pursuant to paragraph (a) of Clause 5.1 above shall be deferred in point of priority to all Fixed Security validly and effectively created by each Chargor under the Secured Debt Documents in favour of the Security Agent as security for the Amended Secured Obligations.
- (c) Paragraph 14 of Schedule B1 to the Insolvency Act 1986 applies to the floating charge created pursuant to paragraph (a) of Clause 5.1 above.

6. EXCLUDED PROPERTY

6.1 Leases Restricting Charging

- (a) There shall be excluded from the charge created by Clause 4.1 (*Fixed Charges*) and from the operation of clause 4 (*Further Assurance*) of the Original Security Agreement (to the extent incorporated into this Third Supplemental Security Agreement) any leasehold property held by a Chargor under a lease which:
 - (i) either precludes absolutely or conditionally (including requiring the consent of any third party) that Chargor from creating any charge over its leasehold interest in that property (each, an "**Excluded Property**") until the relevant condition or waiver has been satisfied or obtained; or
 - (ii) cannot be secured pursuant to this Third Supplemental Security Agreement owing to a restriction imposed by an instrument of government or by law.

- (b) For each Excluded Property, each relevant Chargor undertakes to use its reasonable endeavours promptly to apply for the relevant consent or waiver of prohibition or condition and, in respect of each Excluded Property which provides that the relevant third party will not unreasonably withhold its consent to charging, to use all reasonable endeavours to obtain that consent as soon as possible and to (upon request) keep the Security Agent informed of the progress of its negotiations, provided that, in each case, no such action shall be required if it would require payment by the relevant Chargor of any monetary consideration (other than nominal amounts or expenses) to obtain any such consent or waiver. If consent is being sought from a landlord, any obligation of the relevant Chargor in respect of the consent or waiver referred to in this paragraph (b) shall only extend to investigating the possibility of obtaining such landlord consent and, where in the opinion of the relevant Chargor, (acting reasonably) such consent may be obtained without materially and adversely affecting the commercial relationship between the relevant Chargor and the relevant landlord, the relevant Chargor using reasonable endeavours to obtain such landlord consent.
- (c) Forthwith upon receipt of the relevant waiver or consent, the relevant formerly Excluded Property shall stand charged to the Security Agent under Clause 4.1 (*Fixed Charges*). If required by the Security Agent at any time following receipt of that waiver or consent, the relevant Chargor will forthwith execute a valid legal mortgage (and on terms no more onerous than those in this Third Supplemental Security Agreement), provided that, in each case, no such action shall be required if it would require payment by the relevant Chargor of any monetary consideration (other than nominal amounts or expenses) to obtain any such consent or waiver.

6.2 Intellectual Property Restricting Charging

- (a) There shall be excluded from the charge created by Clause 4.1 (*Fixed Charges*) and from the operation of clause 4 (*Further Assurance*) of the Original Security Agreement (to the extent incorporated into this Third Supplemental Security Agreement) any Material Intellectual Property in which a Chargor has an interest under any licence or other agreement which either precludes absolutely or conditionally (including requiring the consent of any third party) that Chargor from creating any charge over its interest in that Material Intellectual Property (each, an "**Excluded Intellectual Property**") until the relevant condition or waiver has been satisfied or obtained.
- (b) For each Excluded Intellectual Property, each relevant Chargor undertakes to use its reasonable endeavours promptly to apply for the relevant consent or waiver of prohibition or condition and, in respect of any licence or agreement which provides that the relevant third party will not unreasonably withhold its consent to charging, to use its reasonable endeavours to obtain such consent as soon as possible and upon request to keep the Security Agent informed of the progress of its negotiations.
- (c) Forthwith upon receipt of the relevant waiver or consent, the relevant formerly Excluded Intellectual Property shall stand charged to the Security Agent under Clause 4.1 (*Fixed Charges*). If required by the Security Agent, at any time

following receipt of that waiver or consent, the relevant Chargor will forthwith execute a valid fixed charge or legal assignment (and on terms no more onerous than those in this Third Supplemental Security Agreement).

7. MISCELLANEOUS

7.1 Incorporation of provisions from Original Security Agreement

The provisions of clauses 1.3 (*Third Party Rights*), 2 (*Covenant to pay*), 3.5 (*Conversion of Floating Charge*), 3.6 (*Automatic Conversion of Floating Charge*), 4 (*Further Assurance*), 5 (*Representations and warranties*), 6 (*Undertakings - General*), 7 (*Property*), 8 (*Investments*), 9 (*Book Debts*), 10 (*Bank Accounts*), 11 (*Intellectual Property*), 12 (*Hedging Agreements and Assigned Agreements*), 13 (*Insurances*), 15 (*Enforcement*), 16 (*Extension and Variation of Statutory Powers*), 17 (*Status, Powers, Removal and Remuneration of Receiver*), 18 (*Protection of Third Parties*), 19 (*Protection of Security Agent and Receiver*), 20 (*Application of Enforcement Proceeds*), 21 (*Protection of Security*), 22 (*Default Interest*), 23 (*Set-off*), 24 (*Notices*), 25 (*Changes to Parties*), 26 (*Currency*), 27 (*Miscellaneous*) and (other than paragraph (a) of clause 28 (*Governing law and jurisdiction*)) 28 (*Governing law and jurisdiction*) and Schedules 10 (*Form of notice to counterparties*) and 11 (*Form of notice to Account Banks*) of the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) are incorporated into this Third Supplemental Security Agreement as if set out in full in this Third Supplemental Security Agreement, but so that references in those clauses to:

- (a) the "**RCF Facility Agreement**" are references to the "Amended Facilities Agreement";
- (b) the "**Secured Obligations**" are references to the "Amended Secured Obligations";
- (c) "**Charged Property**" are references to the assets of each Chargor charged in favour of, or assigned (whether at law or in equity) to the Security Agent pursuant to this Third Supplemental Security Agreement;
- (d) "**schedule 2 (Property)**", "**schedule 4 (Accounts)**", "**schedule 5 (Assigned Agreements (Contracts))**", "**schedule 6 (Intellectual property)**", "**schedule 7 (Equipment)**" and "**schedule 9 (Insurances)**" are references to Schedule 2 (*Property*), Schedule 3 (*Accounts*), Schedule 4 (*Assigned Agreements (Contracts)*), Schedule 5 (*Intellectual Property*), Schedule 6 (*Equipment*) and Schedule 7 (*Insurances*) respectively; and
- (e) "**this deed**" are references to this Third Supplemental Security Agreement.

7.2 Incorporation of provisions from Intercreditor Agreement

- (a) The provisions of clause 22 (*Costs and Expenses*) of the Intercreditor Agreement shall apply to this Third Supplemental Security Agreement.
- (b) For the avoidance of doubt, clause 23.1 (*Debtors' indemnity*) of the Intercreditor Agreement shall apply to this Third Supplemental Security Agreement to the extent provided in that clause.

7.3 PSC Register

Each Chargor shall comply with any notice served on it by a Subsidiary whose shares such Chargor has charged in favour of the Security Agent in accordance with the terms of this Third Supplemental Security Agreement, pursuant to Part 21A of the Companies Act 2006 and within the timeline specified in the notice. Each such Chargor shall supply the Security Agent with a copy of any such notice promptly on receipt.

7.4 Original Security Agreement

Except insofar as supplemented and amended by this Third Supplemental Security Agreement, the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) shall remain in full force and effect.

7.5 No merger

For the avoidance of doubt, any mortgage, charge or assignment (whether at law or in equity) created by the Original Security Agreement (as supplemented by the First Supplemental Security Agreement and the Second Supplemental Security Agreement) shall continue in full force and effect notwithstanding this Third Supplemental Security Agreement and shall not merge in any security constituted by this Third Supplemental Security Agreement or be released, extinguished or affected in any way by the security constituted by this Third Supplemental Security Agreement.

8. EXTENSION OF POWERS

The power of sale or other disposal conferred on the Security Agent and on any Receiver by this Third Supplemental Security Agreement shall operate as a variation and extension of the statutory power of sale under Section 101 of the Law of Property Act 1925 and such power shall arise (and the Amended Secured Obligations shall be deemed due and payable for that purpose) on the date of this Third Supplemental Security Agreement.

9. POWER OF ATTORNEY

9.1 Appointment

Each Chargor, by way of security, irrevocably and severally appoints the Security Agent, each Receiver and any person nominated for the purpose by the Security Agent or any Receiver (in writing and signed by an officer of the Security Agent or Receiver) as its attorney (with full power of substitution and delegation) in its name and on its behalf and as its act and deed to execute, deliver and perfect any deed, agreement or other instrument and to do any act or thing:

- (a) which that Chargor is required to do by the terms of this Third Supplemental Security Agreement; and/or
- (b) which is for the purpose of enabling the exercise of any rights or powers, conferred on the Security Agent or any Receiver by this Third Supplemental Security Agreement or by law,

and each Chargor covenants with the Security Agent and each Receiver to ratify and confirm all such acts or things made, done or executed by that attorney.

9.2 Exercise of powers

The power given under Clause 9.1 (*Appointment*) may be exercised at any time after:

- (a) the expiry of ten (10) Business Days following the failure by the relevant Chargor to do that which it is required to do by the terms of this Third Supplemental Security Agreement; or
- (b) a Secured Debt Event of Default has occurred, which is continuing.

10. COUNTERPARTS

This Third Supplemental Security Agreement may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Third Supplemental Security Agreement.

11. GOVERNING LAW

This Third Supplemental Security Agreement and any non-contractual obligations arising out of or in connection with it are governed by English law.

THIS THIRD SUPPLEMENTAL SECURITY AGREEMENT has been signed by the Security Agent and executed as a deed by each Chargor and is delivered by it on the date stated at the beginning of this Third Supplemental Security Agreement.

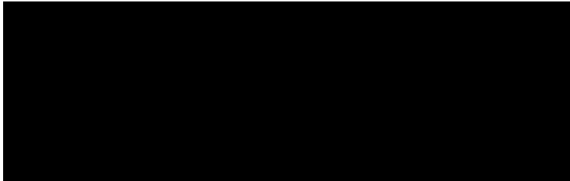

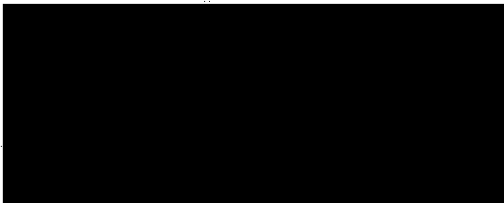
