## POWER OF ATTORNEY

**THIS POWER OF ATTORNEY** made this 18 day of October 2016 by Mark Jeremy Orton of KPMG LLP, One Snowhill, Snowhill Queensway, Birmingham B4 6GH (hereinafter called "the Principal") **WITNESSES** as follows:

1. **THE PRINCIPAL** hereby severally appoints any of the persons listed in the Schedule (each an "Attorney") to be the Attorney of the Principal and in his name and on his behalf and as his act and deed or otherwise:
  - 1.1 generally to execute any deed or sign any document in his own name which may be required and to do any other act matter or thing which the Attorney shall consider necessary or expedient in relation to or in connection with any appointment of the Principal to any office or position as may be held by an insolvency practitioner within the meaning of Part XIII of the Insolvency Act 1986 or any other similar office, appointment or position or as receiver and/or manager of the assets, liabilities or affairs of any individual, corporation, or other person or body of persons, in the same manner and as fully and effectively in all respects as the Principal could have done if personally present;
  - 1.2 for the purposes of this Power of Attorney to appoint and remove at his pleasure any substitute for or agent under him in respect of all or any of the matters set out above upon such terms as the Attorney shall think fit;
  - 1.4 the Principal agrees to indemnify the Attorney against all expenses, losses and liabilities incurred by him when acting in pursuance of this power;
  - 1.5 this Power of Attorney shall expire on the first anniversary of its date;
  - 1.6 this Power of Attorney shall be construed and interpreted according to the law of England and Wales.
2. **THE PRINCIPAL** hereby undertakes to ratify everything which the Attorney or any substitute or agent appointed by him under the aforesaid powers shall do or purport to do by virtue of these presents.
3. **THE PRINCIPAL** may revoke this Power of Attorney in respect of any Attorney by notice in writing to that Attorney without prejudice to and ratifies all acts carried out by that Attorney prior to receiving notice of revocation.
