## 1 Accounting Policies

# Basis of measurement and preparation of accounts

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities effective April 2008.

### **Turnover policy**

The turnover shown in the profit and loss account represents amounts invoiced in the year.

### Tangible assets depreciation policy

Depreciation is calculated so as to write off the cost of an asset, less its estimated residual value over the useful economic life of that asset as follows:

Computer equipment (including website development) - 33.33% on straight line basis

# Valuation information and policy

Product development

Product development expenditure is reviewed at the accounting date to determine whether the criteria, for deferring expenditure, as set out in Statement of Standard Accounting Practice 13 'Accounting for Research & Development' are satisfied. Where the director feels that there is uncertainty regarding the outcome of a project the expenditure is written off in the year it is incurred.

#### Other accounting policies

Going Concern Basis

During the year, the company has failed to generate the level of anticipated sales and as a result has incurred a loss for the year of £10,090. At the balance sheet date there was a deficit in shareholder's funds amounting to £18,657. The director continues to assess operations on an ongoing basis and take the steps she considers necessary to move the company to positive cash flows and profitable trading. In addition, the company's only significant creditor is the balance owed to the director who will only draw from the company as cashflow allows. As a result the going concern basis of accounting has been adopted.
