ORDER	



UPON the application dated 9th November 2021 of Kevin Lucas, of Lucas Ross Limited, Stanmore House, 64 – 68 Blackburn Street, Radcliffe, Manchester, M26 2JS ("Application")

AND UPON the Court being satisfied that the Application can be dealt with without the need for a hearing pursuant to Civil Procedure Rule 23.8(c)

AND UPON READING the evidence

IT IS ORDERED that:

- 1. Pursuant to Section 108 of the Insolvency Act 1986 ("Act") and Rule 12.36(2) of the Insolvency (England & Wales) Rules 2016 ("Rules"), the Applicant, Kevin Lucas, be removed from office as Liquidator of the companies in Creditors Voluntary Liquidation listed in Schedule 1 annexed hereto with effect from 30 November 2021 and the Respondent, John Radford, be appointed as replacement Liquidator in substitution in respect of the said companies with effect from the same date.
- 2. Pursuant to Section 108 of the Act and Rule 12.36(2) of the Rules, the Applicant, Kevin Lucas, be removed from office as Liquidator of the companies in Members Voluntary Liquidation listed in Schedule 2 annexed hereto with effect from 30 November 2021 and the Respondent, John Radford, be appointed as replacement Liquidator in substitution in respect of the said companies with effect from the same date.
- 3. Pursuant to Section 172(2) of the Act and Rule 12.36(2) of the Rules, the Applicant, Kevin Lucas, be removed from office as the Liquidator of the companies in Compulsory Liquidation listed in Schedule 3 annexed hereto with effect from 30 November 2021 and the Respondent, John Radford, be appointed as replacement Liquidator in substitution in respect of the said companies with effect from the same date.
- 4. Pursuant to Section 7(5) of the Act and Rule 12.36(2) of the Rules, the Applicant, Kevin Lucas, be removed from office as Supervisor of the Company Voluntary Arrangements of the companies listed in Schedule 4 annexed hereto with effect from 30 November 2021 and the Respondent, John Radford, be appointed as replacement Supervisor in substitution in respect of the said Company Voluntary Arrangements with effect from the same date.
- 5. Pursuant to Section 298(1) of the Act and Rule 12.36(2) of the Rules, the Applicant, Kevin Lucas, be removed from office as Trustee in Bankruptcy of the bankrupts listed in Schedule 5 annexed hereto with effect from 30 November 2021 and the Respondent, John Radford, be appointed as

- replacement Trustee in Bankruptcy in substitution in respect of the said bankrupts with effect from the same date.
- 6. Pursuant to Paragraph 88 of Schedule B1 to the Act and Rule 12.36(2) of the Rules, the Applicant, Kevin Lucas, be removed from office as Administrator of the companies in Administration listed in Schedule 6 annexed to hereto with effect from 30 November 2021 and the Respondent, John Radford, be appointed as Administrator in substitution in respect of the said companies with effect from the same date.
- 7. The Creditors Voluntary Liquidations, Members Voluntary Liquidations, Compulsory Liquidations, Company Voluntary Arrangements, Bankruptcies, and Administrations listed in schedules 1 to 6 annexed hereto which are (or were) proceeding in a County Court be transferred to the High Court for the purpose of this Order only.
- 8. The creditors of the companies listed in the schedules annexed to this Order be notified of this Order by:
 - 8.1. A single block advertisement published in the London Gazette within 28 days of the date of this Order; such advertisement to include a notice that any creditor may, within 28 days of the advertisement, make an application to Court to set-aside of vary the terms of this Order; and
 - 8.2. Notice given at the same time as the next report pursuant to statute is made to them.
 - 8.3. If an application is made under paragraph 8.1 above, it shall not affect the transfer of the cases listed in Schedules 1 to 6 to the Respondent, until such further Order of the Court.
- 9. The Respondent shall give notice of the terms of this Order to the Secretary of State as soon as is reasonably practicable.
- 10. The Respondent shall file any appropriate notices in respect of the removal of the Applicant and of his respective appointment in replacement with the Secretary of State for Business, Energy & Industrial Strategy (Insolvency Service) and with the Registrar of Companies, as may be required.
- 11. The Applicant shall receive his release and be discharged from liability as officeholder of the companies listed in Schedules 1 to 5 annexed to this Order, 28 days from the date of the



advertisement referred to at paragraph 8.1 in this Order, or such later time as the Secretary of State may determine pursuant to Sections 173(2)(b) and 174(4)(b) of the Act.

- 12. Pursuant to paragraph 98(2)(c) of Schedule B1 to the Act, the Applicant shall be discharged from liability as officeholder of the companies listed in Schedule 6 annexed to this Order, 28 days from the date of the advertisement referred to at paragraph 8.1 of this Order.
- 13. No order as to costs.
