Life Skills Education C I C is a drug and life skills education organisation set up in 2011 to help young people lead safe and healthy lives and achieve their potential. We aim to do this by improving their decision making skills, effective management of risk and taking responsibility for themselves and others. The companies activities have benefitted the community in the following ways.

- Nearly 10,000 young people have gone through a DARE programme addressing issues surrounding Bullying, Peer Group Pressure, Use of Social Media, Theft, Use of Illegal Drugs, Misuse of Legal Drugs, Misuse of Alcohol, Smoking, Solvent Abuse, Cannabis, Personal Responsibility, Dealing with Pressure, Communication, Risks and consequences and Decision making
- 51 organisations downloaded our free DARE Game resource covering Internet Safety and Over the Counter / Legal Drugs
- 25 Teachers were trained in the delivery of life skills topics as well as DARE programmes

All of our programmes seek to gather feedback from young people, teachers and parents This information is collated annually and used to aid amendments and updates to our programmes

Teacher's feedback is gathered using the Quality Standards for Effective Alcohol and Drug Education via our website. These are as prescribed by and created in conjunction with ASDAN

We have also just finalised a significant piece of research on our flagship programme, assessing pre and post responses by children to a series of questions aimed at determining beliefs, attitudes and knowledge of young people. We have assessed 1527 young people from 49 schools across Nottinghamshire, half of which took part on our programme and half that didn't. All were independently invigilated and the final report will be constructed by an independent professor and a PhD student from Nottingham Trent University.

This research will help us understand the effectiveness of our programme and aid us in making the programme better
