IT IS ORDERED THAT:

- 6. The First Respondent, Richard Toone, shall be appointed as Trustee in Bankruptcy in substitution of the Applicant in respect of the Bankruptcies set out in Schedule B hereto in which he is identified as the proposed appointee.
- 7. The Second Respondent, David Oprey, shall be appointed as Trustee in Bankruptcy in substitution of the Applicant in respect of the Bankruptcies set out in Schedule B hereto in which he is identified as the proposed appointee.

- 14. The Second Respondent, David Oprey, shall be appointed as Supervisor in substitution of the Applicant in respect of the Individual Voluntary Arrangement set out in Schedule E hereto.

- 15. The Applicant, Elias Paourou, be removed from his office as Liquidator in respect of the companies in Members' Voluntary Liquidation which are set out in Schedule F hereto.
- 16. The First Respondent, Richard Toone, shall be appointed as Liquidator in substitution of the Applicant in respect of the companies which are set out in Schedule F hereto in which he is identified as the proposed appointee.

- 19. The creditors, members (in the case of Members' Voluntary Liquidations) and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have liberty to apply, within 42 days after the notice has been advertised or the creditors have been written to, to vary or set aside the order made.
- 20. In relation to each of the insolvency proceedings listed in Schedules B, D and F to this Order, the creditors, members (in the case of Members' Voluntary Liquidations) and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have the right to object and make representations to the Applicant in respect of the Applicant's release within 42 days after the notice has been advertised or the creditors have been written to.
- 21. In relation to each of the insolvency proceedings listed in Schedules B, D and F to this Order, the Applicant be entitled to apply to the Secretary of State for his release upon expiry of 42 days from the date the notice referred to in paragraph 18 of this Order has been placed in the London Gazette or the creditors have been written to; and upon expiry of the same time, in relation to each of the insolvency proceedings listed in Schedule A to this Order the Applicant shall be discharged from liability pursuant to paragraph 98 of Schedule B1 to the Insolvency Act 1986 unless any creditor has raised objection in which event discharge within such challenged proceedings shall not occur without further court order.

- 23.
