IN THE EVENT OF A WINDING UP OF A COMPANY, THE HOLDER SHALL BE ENTITLED TO RECEIVE A SUM EQUAL TO THE AGGREGATE OF THE ISSUE PRICE OF THE PREFERRED SHARES IN ISSUE AT THE RELEVANT DATE PLUS ALL ACCRUED BUT UNPAID REFERRED DIVIDENS AT THE RELEVANT DATE DIVIDED BY THE NUMBER OF PREFERRED SHARES THEN IN ISSUE. FOLLOWING THE DATE OF REDEMPTION OF THE PREFERRED SHARES, TO THE EXTENT THAT PAYMENT OUT OF PROFITS WOULD BE LAWFUL, EACH HOLDER OF PREFERRED SHARES SHALL BE ENTITLED TO RECEIVE, IN PRIORITY TO THE HOLDERS OF ANY OTHER CLASS OF SHARE, AND THE COMPANY SHALL PAY A FIXED CUMULATIVE PREFERENTIAL DIVIDEND AT THE RATE OF 6 PER CENT PER ANNUM OF THE ISSUE PRICE OF SUCH SHARE. THE HOLDERS OF THE PREFERRED SHARES SHALL HAVE NO RIGHT TO RECEIVE NOTICE OF OR TO ATTEND OR VOTE AT ANY GENERAL MEETING OF THE COMPANY.
