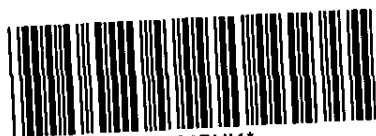

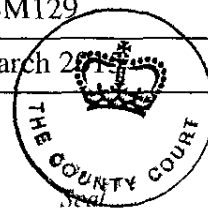

- 3 If the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(i) and (b) of the Companies Act 2006 change the name of the Company to 07839486 Limited
- 4 The Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- 5 In the event that the Claimant fail to comply with undertaking(c) above the Register of Companies be at liberty to commence strike off action in respect of the Company without further to the Claimant
