1 Accounting policies

The financial statements are prepared under the historic cost convention and in accordance with applicable United Kingdom accounting standards. The following principal accounting policies have been applied consistently during the financial period. The particular accounting policies adopted are described below.

a) Accounting convention

The financial statements are prepared on the going concern basis as discussed in the Strategic Report and Directors' Report under the historical cost convention

b) Going concern

The Company's financial position and future prospects are described in the Strategic Report and Directors' Report. The Company achieved a good level of profit and its financial position was strong. This, combined with the support of its ultimate parent Company (Senior plc), give the directors the expectation that the Company will have adequate resources to continue in existence for the foreseeable future. Thus, the Board has continued to adopt the going concern basis in preparing the Company's financial statements.

c) Taxation

UK corporation tax is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantially enacted by the balance sheet date

d) Foreign currencies

Transactions denominated in foreign currencies are recorded in US Dollars at actual exchange rates as of the date of the transaction. Monetary assets and liabilities denominated in foreign currencies at the year end are reported at the rates of exchange prevailing at the period end. Any gain or loss arising from a change in exchange rates subsequent to the date of the transaction is included as exchange gain or loss in the profit and loss account.

e) Cash flow statement

As permitted by Financial Reporting Standard No 1 (Revised), the Company has not produced a cashflow statement, as it is a wholly owned subsidiary undertaking of Senior plc, which has produced a Group cashflow statement in its accounts

9 Guarantees

a) Private placement loans

The Company is a guarantor, jointly and severally, with certain other Group companies, of US \$120 million (2012 – \$120 million) unsecured loan notes under an agreement dated 8 October 2008 Loan notes of US \$25 million, \$75 million and \$20 million are due for repayment in October 2015, October 2018 and October 2020 respectively

The Company is a guarantor, jointly and severally, with certain other Group companies, of US \$30 million (2012 – \$30 million) unsecured loan notes under an agreement dated 31 January 2007 and are due for repayment in January 2017

The Company is a guarantor, jointly and severally, with certain other Group companies of US \$35 million (2012 – \$35 million) unsecured loan notes under an agreement dated 22 October 2007 and are due for repayment in October 2014

b) Bank guarantees

The Company is a guarantor, jointly and severally, with certain other Group companies of all indebtedness of certain US Group companies to their US clearing banker, including a committed single bank US \$25 million overdraft (2012 – \$50m overdraft) and letter of credit facility. This was entered into in December 2012 and matures in May 2015. At 31 December 2013 there was US \$4.7 million letters of credit issued (2012 – US \$14.5 million) and no overdrafts drawn under the new facility (2012 – US \$nil).

c) Revolving credit facility

The Company is a guarantor, jointly and severally, with certain other Group companies of a committed £60 million syndicated multi-currency revolving credit facility maturing in October 2016. There were no amounts drawn under either of these facilities as at 31 December 2013 and 31 December 2012.

10 Ultimate parent company

The Company's immediate parent Company is Senior Engineering Investments Limited

The Company's ultimate parent Company and controlling party, which prepares consolidated accounts incorporating the Company's results, is Senior plc, whose registered office is at 59/61 High Street, Rickmansworth, Hertfordshire WD3 1RH.
