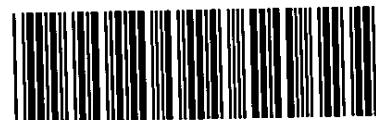

Notes to the financial statements
for the period ended 31 March 2013

1. Accounting policies

1.1. Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

The company which contracts with third parties in its own name for the supply of maintenance and services to the communal areas of the property, has no income or expenditure in its own right. All transactions in the year relate to maintenance of the communal areas in accordance with the lease. Income and expenditure arising from these transactions is shown in separate service charge accounts for the property that do not form part of the annual statutory accounts and are not filed at Companies House. All service charge monies received from individual lessees are held on trust for the lessees, as a body.

1.2 Compliance with accounting standards

The financial statements are prepared in accordance with applicable United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), which have been applied consistently (except as otherwise stated).

2. Guarantee

Every member of the Company undertakes to contribute such amount as may be required, not exceeding £1, to the assets of the Company in the event of the Company being wound up whilst a member, or within one year of ceasing to be a member, for payment of the debts and liabilities of the Company contracted before ceasing to be a member, and of the costs, charges and expenses of winding up the Company, and for the adjustment of the rights of the contributories among themselves.
