The company commenced operations in September 2012 and achieved a turnover of £27,396 Some 50% of this was from a university educational field trip to the Canaries and the balance was from student experiential learning opportunities. Expenditure was slightly in excess of revenues resulting in a £298 reduction in capital represented by cash held in the bank, there being no assets in the business
