The following resolution was passed as a Special Resolution

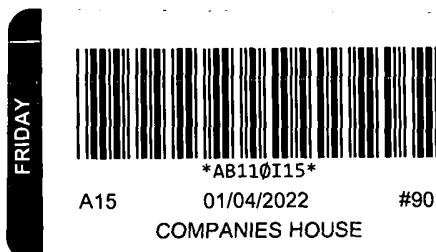
