1 Statutory information

Bristol Pub Gas Limited is a private company, limited by shares, registered in England and Wales, registration number 07915238. The registered office and principal place of business is 63 Anthea Road, Fishponds Trading Estate, Bristol, BS5 7EX.

2 Average number of employees

During the year the average number of employees was 5 (2019: 4).

For the year ending 31 January 2020 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.
