1. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES

At 1st April 2014, the directors' loan account was a credit balance of £32,890. During the year, the directors paid £3,059 for the company expenses. As a result at the year end the company owed £35,949 to the directors.
