SPECIAL RESOLUTIONS

- 1. **THAT** the draft articles of association attached to these Resolutions be approved and adopted as the articles of association of the Company in substitution for, and to the exclusion of, the existing articles of association of the Company.
- 2. **THAT**, subject to the passing of resolutions 1 and 4 and in accordance with section 570 of the Act, the directors of the Company (**Directors**) be generally empowered to allot equity securities (as defined in section 560 of the Act) pursuant to the authority conferred by resolution 4, as if section 561(1) of the Act and article 9 of the Company's articles of association did not apply to any such allotment, provided that this power shall:
 - a) be limited to the allotment of equity securities up to an aggregate nominal amount of $\pounds 581$; and
 - b) expire on the fifth anniversary of the date of these Resolutions (unless renewed, varied or revoked by the Company prior to or on that date), save that the Company may, before such expiry, make an offer or agreement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of any such offer or agreement notwithstanding that the power conferred by this resolution has expired.

ORDINARY RESOLUTIONS

3. **THAT**, the ordinary shares of £0.0001 each set out below be redesignated as A shares of £0.0001 each, as set out below, such shares having the rights and being subject to the restrictions set out in the articles of association adopted pursuant to resolution 1.

This authority revokes and replaces all unexercised authorities previously granted to the Directors, other than the authority granted in accordance with the written resolution of the Company dated 30 November 2021 but without prejudice to any allotment of shares or grant of Rights already made or offered or agreed to be made pursuant to such authorities.
