## IT IS ORDERED THAT:

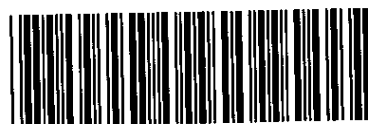
1. The name of 1. XPLOER PLC (registration number 07987393) be restored to the Register of Companies
