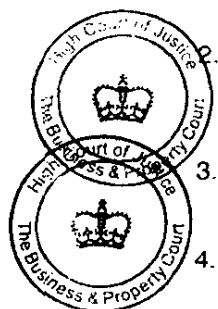

UPON THE APPLICATION of Julian Nigel Richard Pitts and others

AND UPON reading the witness statement of Julian Nigel Richard Pitts dated 26
April 2018

IT IS HEREBY ORDERED as follows:

1. In respect of those Company Voluntary Arrangements, Administrations, Creditors' Voluntary Liquidations, Members' Voluntary Liquidations, Compulsory Liquidations, Bankruptcies and Individual Voluntary Arrangements, as listed in the Schedule to this Order and which are the subject of proceedings in County Court, the Companies Court or other District Registries in England and Wales, those proceedings be transferred to the High Court, Business and Property Court in Leeds, Insolvency and Companies List (ChD) solely for the purpose of this application and thereafter transferred back to the relevant Court.



The first named Respondent, Robert Sadler, be removed from office as Administrator, Liquidator, Trustee and Supervisor (as the case may be) of the estates listed in the Schedule with ~~effect~~ immediate effect.

3. The relevant Applicant be appointed as the replacement office-holder with immediate effect as set out in the Schedule in the column headed Replacement IP.

4. Robert Sadler be granted his release or discharge from all liability as appropriate 21 days after the publication in the London Gazette or the filing with the Registrar of Companies or the notification to the Secretary of State (whichever is the earliest) as required by paragraph 5 below, without being required to apply for his release or file a receipts and payment account.

5. The Applicants shall as soon as reasonably practicable following receipt of the sealed Order:

5.1 Publish in the London Gazette one composite notice relating to all new appointments under this order;

5.2 In relation to those cases where they are the continuing or replacement office-holder and to the extent required by law:

5.2.1 file with the Registrar of Companies any notices in respect of Robert Sadler's removal and replacement; and

5.2.2 notify the Secretary of State of the making of this Order.

6. The Applicants shall, in relation to those cases where they are the continuing or replacement office-holder, notify creditors (and members where appropriate), in their next routine report of the making of this Order and provide an explanation of the effects of this Order including specifically referring to creditors' liberty to apply to discharge or vary this Order.
7. Subject to paragraph 8 and 10 below, in the event that, as a result of the implementation of the Order, Begbies Traynor (Central) LLP incurs any additional costs in respect of the administration of those estates where Robert Sadler was the office holder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by Begbies Traynor (Central) LLP and shall not be charged as an expense of those estates.
8. Nothing contained in paragraph 7 shall prejudice the relevant Applicant(s) from:
 - 8.1 Charging to each individual estate the cost of obtaining an insolvency practitioners licence bond in respect of that estate; and
 - 8.2 Apportioning equally between the said estates the cost of the composite London Gazette notice under paragraph 5 above.
9. The liberty to each creditor of each estate to apply to vary or discharge this Order within 21 days of the receipt of the notice directly to be sent under paragraph 6 above.
10. The cost of this application (including VAT) be aggregated and apportioned equally between each of the estates listed in the Schedule to be drawn as disbursements as and when sufficient funds are available. The Respondents will bear their own costs of this application.
