3. DIRECTOR'S ADVANCES, CREDITS AND GUARANTEES - continued

During the year advances of £83,278 were made to the director and these were repayable on demand. The director was entitled to dividends of £90,500 and salary of £8,600. The company charges interest of £682 at official HMRC rates.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2020.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 March 2020 in accordance with Section 476 of the Companies Act 2006.
