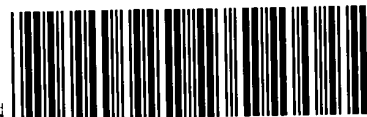

Resignation as a Director of 2DKA Limited

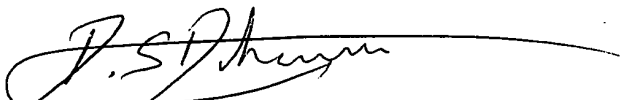
Please accept this letter as my formal resignation with immediate effect from the board of directors of 2DKA Limited.
